15 Section 1. The Board of Supervisors hereby adopts and implements the First
16 Amendment to the 2024-2027 Memorandum of Understanding (“MOU”) between the City and
17 County of San Francisco and Service Employees International Union, Local 1021, Staff and
18 Per Diem Nurses to address staffing and hiring of 2320 Registered Nurses and 2830 Public
19 Health Nurses.

20 The First Amendment to the MOU so implemented is on file with the Clerk of the Board
21 of Supervisors in Board File No. 240722.

22 Section 2. The Board of Supervisors hereby authorizes the Department of Human
23 Resources to make non-substantive ministerial or administrative corrections to the MOU.
