9 **of the settlement are a payment to Plaintiff by Defendant/Cross-Defendant Pacific Bell**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
14 authorizes the City Attorney to settle the action entitled Robert Lasky v. City and County of
15 San Francisco, et al., San Francisco Superior Court, Case No. CGC-21-594463 for the
16 payment to the City of \$100,000 by Defendant/Cross-Defendant Pacific Bell Telephone
17 Company. The lawsuit involves personal injuries sustained on a utility vault owned by Cross-
18 Defendant Pacific Bell Telephone Company and embedded in a City sidewalk.

19 Section 2. The above-named action was filed in San Francisco Superior Court on
20 August 13, 2021, and the following parties were named in the lawsuit: Plaintiff: Robert Lasky;
21 Defendant: AT&T Risk Management; Defendant/Cross-Complainant: City and County of San


