

1 [Appointment, Child Care Planning and Advisory Council - Claudia Quinonez]

2  
3 **Motion appointing Claudia Quinonez (residency requirement waived), term ending**  
4 **March 19, 2027, to the Child Care Planning and Advisory Council (District 4).**

5  
6 MOVED, That the Board of Supervisors of the City and County of San Francisco does  
7 hereby appoint the hereinafter designated persons to serve as members of the Child Care  
8 Planning and Advisory Council, pursuant to the provisions of the Administrative Code, Article  
9 XX, Section 5.200; Administrative Code XIII, Section 10.100-367; and California Education  
10 Code, Sections 8499.3-8499.7, for the terms specified:

11 Claudia Quinonez (residency requirement waived), seat 4, succeeding Ivy Ng, term  
12 expired, must be a nominee of the District 4 Supervisor and represent one of the following  
13 categories: consumers, child care providers, discretionary, community representatives, or  
14 public agency representatives, for a three-year term ending March 19, 2027; and, be it

15 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 16 1. The membership of the Child Care Planning and Advisory Council has a goal to be  
17 representative of the diversity of the City and County of San Francisco.
- 18 2. Applicant Claudia Quinonez, who is not a resident of San Francisco, is a person with  
19 experience that uniquely qualifies them to serve on the Child Care Planning and  
20 Advisory Council.
- 21 3. The Child Care Planning and Advisory Council has attempted to fill the position, for  
22 which Claudia Quinonez was nominated, with an individual who is City a resident and  
23 who has the specific experience, skills, and qualifications, but has been unable to do so  
24 at this time. The Rules Committee has certified that Claudia Quinonez is qualified to  
25 serve on the Child Care Planning and Advisory Council.

1 4. After exercising due diligence, the Board of Supervisors concludes that there is no  
2 other possible representatives who is a resident of San Francisco, who has the specific  
3 experience, skills, or qualifications possessed by this applicant, and who is willing to  
4 serve on the Child Care Planning and Advisory Council at this time; and, be it  
5 FURTHER MOVED, That the Board of Supervisors waives the residency requirement  
6 for Claudia Quinonez, as is allowed in cases where no qualified City resident who is willing to  
7 serve can be found, pursuant to Charter, Section 4.101(b), that otherwise requires person(s)  
8 appointed to boards, commissions, and advisory bodies established by legislative act of the  
9 Board of Supervisors to be resident(s) of the City and County of San Francisco.


