3 **Ordinance authorizing settlement of the lawsuit filed by Steven Benvenuto against the**  
4 **City and County of San Francisco for \$70,000; the lawsuit was filed on February 15,**  
5 **2023, in San Francisco Superior Court, Case No. CGC-23-604629; entitled Steven**  
6 **Benvenuto v. City and County of San Francisco, et al.; the lawsuit involves alleged**  
7 **property damage and personal injury arising from a vehicle collision.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Steven Benvenuto v. City and County  
12 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-23-604629 by the  
13 payment of \$70,000. The lawsuit involves alleged property damage and personal injury  
14 arising from a vehicle collision.

15 Section 2. The above-named action was filed in San Francisco Superior Court on  
16 February 15, 2023, and the following parties were named in the lawsuit: Plaintiff: Steven  
17 Benvenuto, Defendants: City and County of San Francisco and Danny Bosbely DeLeon  
18 Garcia.
