5 **San Francisco Superior Court, Case No. CGC-21-597312; entitled Rick Lam v. City and**
6 **County of San Francisco et al.; the lawsuit involves an employment dispute.**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Rick Lam v. City and County of San
11 Francisco et al, San Francisco Superior Court, Case No. CGC-21-597312, by the payment of
12 \$350,000. The lawsuit involves an employment dispute.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 December 27, 2021, and the following parties were named in the lawsuit: Plaintiff: Rick Lam;
16 Defendants: City and County of San Francisco, Fine Arts Museums of San Francisco,
