

1 [Grant Applications and Agreements - Advocates for Human Potential, Inc. - Bond Round 1
2 Launch Ready Program - Anticipated Revenue to the City in Excess of \$70,000,000]

3 **Resolution authorizing the San Francisco Department of Public Health (SFPDH) to**
4 **submit applications for Grant funds to the California Department of Health Care**
5 **Services, through its contractor Advocates for Human Potential, Inc., under the**
6 **Behavioral Health Continuum Infrastructure Bond Round 1 Launch Ready Program,**
7 **pursuant to the Behavioral Health Infrastructure Bond Act of 2024, for a term not to**
8 **exceed 10 years, with anticipated revenue to the City in excess of \$70,000,000; to enter**
9 **into Grant Agreements, if one or more is awarded, including binding arbitration and/or**
10 **a waiver of claims against the State or its third-party Grant Administrator; and**
11 **authorizing SFPDH to enter into amendments or modifications to the Grant Agreements**
12 **that do not materially increase the obligations or liabilities of the City and are**
13 **necessary to effectuate the purpose of the Grant.**

15 WHEREAS, On July 15, 2024, the California Department of Health Care Services
16 (CDHCS), through its contractor Advocates for Human Potential, Inc., issued a Request for
17 Applications for Grant funds distributed under the Behavioral Health Continuum Infrastructure
18 Round 1 Launch Ready Program, pursuant to Behavioral Health Infrastructure Bond Act of
19 2024; and

20 WHEREAS, Program funding allocations are subject to the terms and conditions of the
21 Requests for Applications, the Application, Program Funding Agreement, and all other legal
22 requirements of the Program; and

23 WHEREAS, CDHCS requires that the governing body of the applicant jurisdiction
24 formally pre-authorize the City to (1) submit applications for Grant funds; (2) accept Grant
25 funds if DPH's Grant Applications are approved, with the understanding that all Grant funds

1 must be used for the allowable expenditures and activities identified in the Grant Agreement,
2 and (3) agree to all Grant terms, including binding arbitration and/or a waiver of claims against
3 CDHCS or its third-party Grant Administrator; now, therefore, be it

4 RESOLVED, That DPH is hereby authorized to submit the Applications to CDHCS for
5 Program Grant funds in an amount anticipated to exceed \$70,000,000; and, be it

6 FURTHER RESOLVED, That SFDPH acknowledges and agrees that it shall be subject
7 to the terms and conditions specified in the Program Funding Agreements, and that any and
8 all activities, expenditures, information, and timelines represented in the Applications are
9 enforceable through the Program Funding Agreements; and, be it

10 FURTHER RESOLVED, That if the Applications are approved, SFDPH is hereby
11 authorized to enter into the Grant Agreements for the total award amount, and is further
12 hereby authorized to agree to all Grant Agreement terms, including binding arbitration and/or
13 a waiver of claims against CDHCS or its third-party Grant Administrator; and, be it

14 FURTHER RESOLVED, That Grant funds are to be used for the allowable
15 expenditures and activities identified in the Grant Agreements; and, be it

16 FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the Director
17 of Health to execute the Applications and Program Documents on behalf of Applicant for
18 participation in the Program and enter into any amendments or modifications to the Grant that
19 the Department determines, in consultation with the City Attorney, are in the best interests of
20 the City, do not otherwise materially increase the obligations or liabilities of the City, are
21 necessary to effectuate the purposes of the Grant, and are in compliance with all applicable
22 laws; and, be it

23 FURTHER RESOLVED, That within 30 days of the Program Funding Agreements
24 being fully executed by all parties, DPH shall submit to the Clerk of the Board of Supervisors
25 the Grant Applications and a completely executed copy of the Program Funding Agreements

1 for inclusion in File No. 241097; this requirement and obligation resides with the Department,
2 and is for purposes of having a complete file only, and in no manner affects the validity of the
3 approved Program Funding Agreements.


