I am writing to express my strongest recommendation for Joanna Gubman to be appointed to the SF Board of Appeals. I am writing in my capacity as the co-Lead of Urban Environmentalists Illinois, an Illinois organization that advocates for inclusive and abundant cities with better housing, clean public transit and healthier built environments. I have had the opportunity to work actively with Joanna, in her former capacity as the Executive Director for the national Urban Environmentalists organization. I believe that her methodological approach to decision making, constructive problem solving skills, deep understanding of the nuances of legislative policies and procedures, and ability to bring diverse coalitions to consensus make her uniquely qualified for this position.

Joanna oversaw the development of Urban Environmentalists Illinois from an organization of a few people to nearly 2000 members (we are now at ~3500).
