- 1) Traffic could easily be diverted to Monterey Boulevard (one block north), which was already a long-established major thoroughfare.
- 2) The existence of two elementary schools on Hearst Avenue, where a number of parents were cycling their kids to and from school.

Upon coming together as a group, Sara immediately rose to a leadership position. She knew exactly how to move forward, how to communicate positively to the neighborhood and more importantly, how to bring the neighborhood together. Slow Hearst has become a successful slow street, with strong neighborhood support and ample usage by cyclists and walkers to more than justify the existence of the slow street designation. I personally see a significant number of parents cycling their children, to school and elsewhere. This is exactly how we envisioned it.

Sara is extremely bright, articulate and exudes enthusiasm in whatever project she pursues, or challenges she faces. She has great ideas and imagination to bring to the table. As a young mother and professional, she can see different perspectives and be creative in coming up with solutions or ideas. I am lucky to call her a friend.
