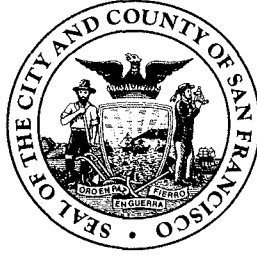

2 Project - California Street at Presidio Avenue]

3 **Ordinance approving an amendment to a Development Agreement (originally approved**  
4 **by Ordinance No. 276-19) for the 3333 California Street project between the City and**  
5 **County of San Francisco and Laurel Heights Partners, LLC, to extend the term of the**  
6 **Development Agreement by eight years to September 11, 2043, modify the affordable**  
7 **housing requirements, allow the project to qualify for the Temporary Fee Reduction**  
8 **Program under Planning Code, Section 403, and include a finance plan with a**  
9 **framework to use incremental property tax revenue to fund the Project's public capital**  
10 **facilities and affordable housing; making findings under the California Environmental**  
11 **Quality Act; and making findings of conformity with the General Plan, and the eight**  
12 **priority policies of Planning Code, Section 101.1(b), and findings of public**  
13 **convenience, necessity, and welfare under Planning Code, Section 302.**

22 Be it ordained by the People of the City and County of San Francisco:

23 Section 1. Background.

24 (a) Laurel Heights Partners, LLC, a Delaware limited liability company  
25 ("Developer"), owns approximately 10.25 acres in San Francisco, generally bounded by  
California Street, Laurel Street, Euclid Avenue, Masonic Avenue, and Presidio Avenue  
("Developer Property").

1 (b) The Developer and the City and County of San Francisco ("City") executed a  
2 Development Agreement, dated as of September 11, 2020, relating to Developer's proposed  
3 development of a mixed-use project with residential, non-residential, open space, child care,  
4 and related uses ("Project") on the Developer Property ("Original Agreement"). The Original  
5 Agreement was approved by the Board of Supervisors and Mayor in Ordinance No. 276-19  
6 ("2019 Ordinance"). Copies of the Original Agreement and the 2019 Ordinance are on file  
7 with the Clerk of the Board of Supervisors in File No. 190845.

8 (c) Section 11.1 of the Original Agreement authorizes the Director of Planning to  
9 enter into an amendment to the Original Agreement if it does not constitute a Material Change  
10 (as defined in the Original Agreement). Under such authority, the Original Agreement was  
11 amended by a Memorandum of Minor Modification of Development Agreement (Amendment  
12 No. 1) dated as of June 5, 2024 ("Minor Modification"), a copy of which is on file with the Clerk  
13 of the Board of Supervisors in File No. 240797.

14 (d) The Developer and City wish to further amend the Original Agreement, as  
15 modified by the Minor Modification ("Modified Development Agreement"), with an amendment  
16 ("Second Amendment") that would: (i) extend the term of the Modified Development  
17 Agreement, the deadline to commence construction, and the outside date to complete  
18 construction of the affordable units, (ii) reduce the required number of affordable units, extend  
19 the timing for escrow deposits to fund the development of the affordable units, and authorize  
20 the Director of the Mayor's Office of Housing and Community Development to make certain  
21 changes to the affordable unit requirements, (iii) allow the project to qualify for the Temporary  
22 Fee Reduction Program under Planning Code Section 403, and (iv) include a financing plan  
23 with the framework for using incremental property tax revenue to fund the Project's public  
24 capital facilities and affordable housing, providing significant benefits to Enhanced  
25 Infrastructure Financing District No. 3 (3333/3700 California Street) ("EIFD No. 3") or the

1 surrounding community, and make necessary revisions to the Modified Development  
2 Agreement for the establishment of EIFD No. 3 and use of that incremental property tax  
3 revenue.

4 (e) By Resolution No. 553-24, a copy of which is on file with the Clerk of the Board  
5 of Supervisors in File No. 240816, the Board of Supervisors approved the Resolution of  
6 Intention to Establish San Francisco Enhanced Infrastructure Financing District No. 3  
7 (3333/3700 California Street) to provide financial assistance for both Developer's public  
8 infrastructure obligations for the Project, and Developer's proposed mixed-use development  
9 project at an 4.84-acre site owned by Developer and located on California Street between  
10 Maple Street and Cherry Street.

11 (f) The Developer and City have worked over the last year to identify modifications  
12 to the terms of the Modified Development Agreement that will improve financial feasibility and  
13 expedite delivery of the Project. Factors such as increases in construction and labor costs, a  
14 worldwide pandemic, rising interest rates, and a slowing of the real estate market have  
15 delayed the initiation of the Project. However, advancing the Project is critical to meeting the  
16 City's housing production goals established under its Housing Element 2022 Update of the  
17 General Plan and the Mayor's Housing for All implementation strategy. The proposed  
18 modifications to the Modified Development Agreement, along with the formation of EIFD No.  
19 3, will enable the advancement of the Project and provide much-needed new market rate and  
20 senior affordable housing in a high-resource district in San Francisco.

21 Section 2. Temporary Fee Reduction Program and Planning Code Conformity.

22 The Board of Supervisors approves allowing the Project to qualify as a Pipeline Project,  
23 as defined in Planning Code Section 415A.2, for the Temporary Fee Reduction Program  
24 under Planning Code Section 403 and as specified in the Second Amendment, and waives  
25 any inconsistent provision in Planning Code Section 403.

1           Section 3. Environmental and Land Use Findings.

2           (a)     On September 5, 2019, by Motion No. 20512, the Planning Commission certified  
3 as adequate, accurate, and complete the Final Environmental Impact Report ("FEIR") for the  
4 Project pursuant to the California Environmental Quality Act (California Public Resources  
5 Code Sections 21000 et seq.) ("CEQA"). A copy of Planning Commission Motion No. 20512  
6 is on file with the Clerk of the Board of Supervisors in File No. 240797.

7           (b)     On October 10, 2024, the Planning Department issued an addendum to the  
8 FEIR ("FEIR Addendum") finding the Second Amendment would not change the conclusions  
9 in the FEIR and the amendment would not result in any new or more severe environmental  
10 impacts than were previously identified in the FEIR. A copy of the FEIR Addendum is on file  
11 with the Clerk of the Board of Supervisors in File No. 240797.

12           (c)     The Board of Supervisors has reviewed and considered the FEIR and the FEIR  
13 Addendum, and finds the FEIR and the FEIR Addendum are adequate for their use for the  
14 actions taken by this ordinance and incorporates herein the FEIR and the CEQA findings  
15 contained in Ordinance No. 276-19 and the FEIR Addendum by this reference, and further  
16 finds that, pursuant to CEQA Guidelines Section 15162, no additional environmental review is  
17 required because there are no substantial changes to the Project analyzed in the FEIR and  
18 the FEIR Addendum, no change in circumstances under which the Project is being  
19 undertaken, and no new information that was not known and could not have been known  
20 shows that new significant impacts would occur, that the impacts identified in the FEIR and  
21 the FEIR Addendum as significant impacts would be substantially more severe, or that  
22 mitigation or alternatives previously found infeasible are now feasible.

23           (d)     The Board of Supervisors found the Original Agreement conforms with the General  
24 Plan and the eight priority policies of Planning Code Section 101.1 by the findings set forth in  
25 Section 3 of the 2019 Ordinance. The Board of Supervisors incorporates herein the foregoing

1 findings and determines that said findings are adequate to establish that the actions taken by  
2 this ordinance to approve the Second Amendment conform with the General Plan and the  
3 eight priority policies of Planning Code Section 101.1.

4 (e) Pursuant to Planning Code Section 302, the Board of Supervisors finds that this  
5 ordinance will serve the public necessity, convenience, and general welfare for the reasons  
6 set forth in Planning Commission Resolution No. 21628, and the Board adopts such reasons  
7 as its own. A copy of that resolution is on file with the Clerk of the Board of Supervisors in File  
8 No. 240797 and is incorporated herein by reference.

9 Section 4. Development Agreement Amendment.

10 (a) The Board of Supervisors approves all the terms and conditions of the Second  
11 Amendment in substantially the form on file with the Clerk of the Board of Supervisors in File  
12 No. 240797.

13 (b) The Board of Supervisors approves and authorizes the execution, delivery, and  
14 performance by the City of the Second Amendment as follows: (1) the Director of Planning  
15 (and other City officials listed thereon) are authorized to execute and deliver the Second  
16 Amendment, and (2) the Director of Planning and other applicable City officials are authorized  
17 to take all actions reasonably necessary or prudent to perform the City's obligations under the  
18 Modified Development Agreement in accordance with the terms of the Second Amendment.

19 (c) The Board of Supervisors finds that this ordinance satisfies the requirements of  
20 both Article 11 of the Original Agreement and Article 56 of the Administrative Code as  
21 governing the amendment of the Modified Development Agreement.

22 Section 5. Direction to Clerk of the Board of Supervisors.

23 The Clerk of the Board of Supervisors is directed to place a copy of this ordinance in  
24 File No. 190845, the file for the 2019 Ordinance (Ordinance No. 276-19).

25 Section 6. Effective Date.

1 This ordinance shall become effective 30 days after enactment. Enactment occurs  
2 when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned, or the Mayor  
3 does not sign the ordinance within ten days of receiving it, or the Board of Supervisors  
4 overrides the Mayor's veto of the ordinance.
