5 **in San Francisco Superior Court, Case No. CGC-23-607826; entitled Arthur Bailey Jr. v.**
6 **City and County of San Francisco; the lawsuit involves an alleged personal injury on a**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Arthur Bailey Jr. v. City and County of
12 San Francisco, San Francisco Superior Court, Case No. CGC-23-607826 by the payment of
13 \$320,000. The lawsuit involves an alleged personal injury on a City Street.

14 Section 2. The above-named action was filed in San Francisco Superior Court on July
15 21, 2023, and the following parties were named in the lawsuit: Plaintiff; Arthur Bailey Jr.;
16 Defendant; City and County of San Francisco.
