## Inflation Reduction Act of 2022 (IRA) Assistance for the Adoption of the Latest and Zero Building Energy Codes

- Grant Award Amount: \$19,994,217
- Funding source(s): US Department of Energy, State and Community Energy Programs
- **Scope:** San Francisco will partner with the City of Berkeley and regional entities to adopt, implement, and enforce Building Performance Standards (BPS) that reduce energy use and carbon emissions locally; deliver technical assistance to disadvantaged communities; and prepare Alameda County and the Bay Area for adoption. San Francisco targets a 90% emissions reduction from compliant buildings by 2040.

## Clean Cities and Communities Energy and Environmental Justice Initiative – Community Engagement Liaison Cohort 2

- Award Amount: \$284,800
- Funding source(s): US Department of Energy
- Scope: Hire a new Community Engagement Liaison (CEL) position for two years to support energy and environmental justice work to remove barriers to implementing effective programming in underserved communities and develop best practices for future community engagement. Develop a Community Mapping and Engagement Plan to engage with 3-5 underserved communities.

# Charging & Fueling Infrastructure Discretionary Grant Program

- Award Amount: \$14,996,876
- Funding source(s): US Department of Transportation
- Scope: Install up to 270 Level 2 and 30 DC Fast Charging ports in publicly accessible garages/lots and at curbside locations in/adjacent to Justice40 disadvantaged communities, and conduct associated outreach/engagement, education, and project evaluation

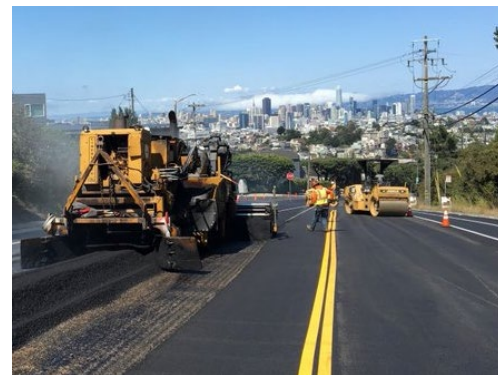
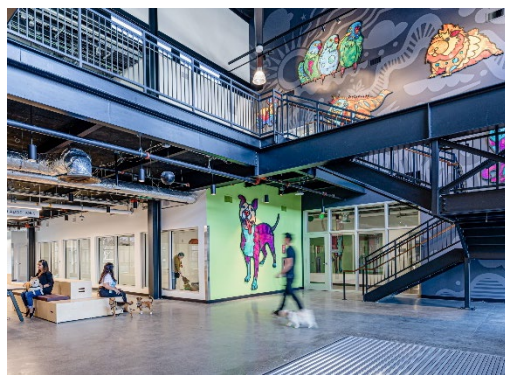
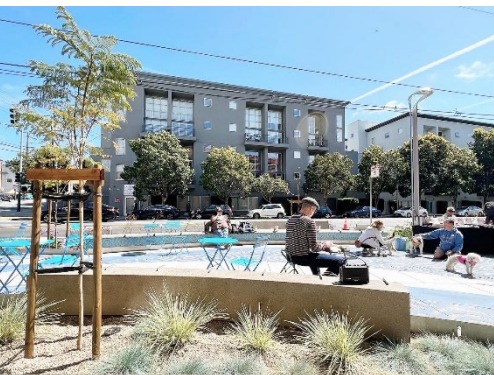

**Bayview Connections Project: Phase 1 Harney Way Bus Rapid Transit and Cycle Track**

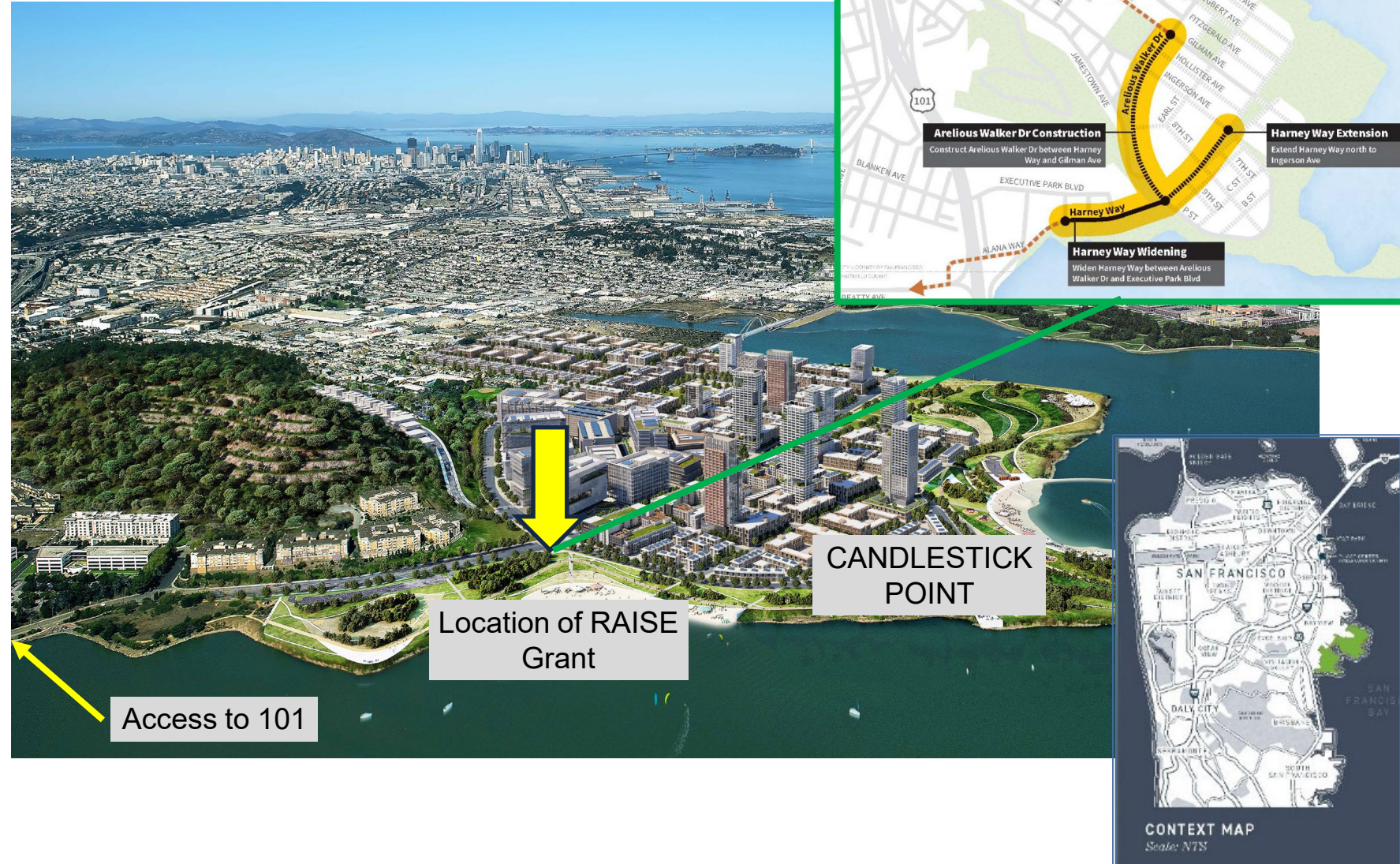

# Bayview Connections Project: Phase 1 Harney Way Bus Rapid Transit and Cycle Track

- \$20M USDOT RAISE Grant awarded to Public Works for Bayview Connections Project. Developer will contribute \$26M to project.
- Part of Candlestick Point development area, District 10.
- First phase of larger plan to upgrade roadway network to improve connectivity between southeast neighborhoods and regional employment and activity centers.
- New streets will include BRT lanes, separated cycletracks, wide sidewalks







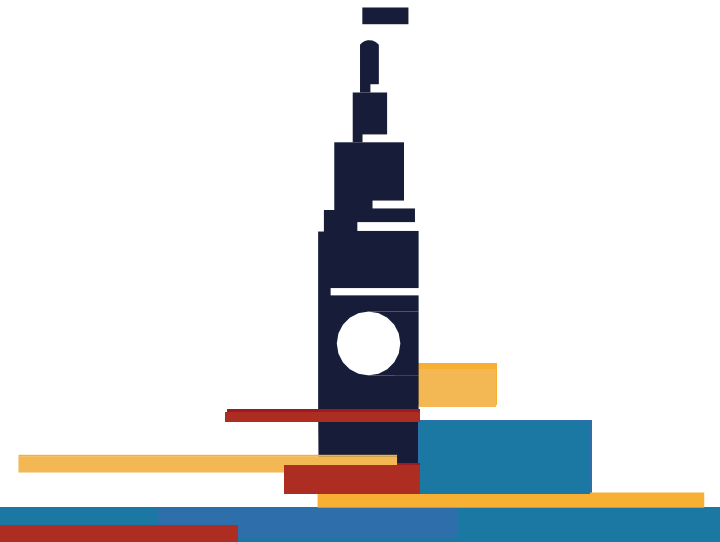

# Federal Emergency Management Agency

## Building Resilient Infrastructure and Communities (BRIC)

### PROJECT SCOPE

- Funds Engineering with Nature Working Group
  - To build capacity of nature-based solutions for future hazard mitigation projects
    - Review bathymetry, hydrological & ecological conditions
    - Review global adaptation strategies and best practices
    - Design charettes & project scoping
    - Develop final report for integrating nature-based solutions into waterfront adaption projects eligible for BRIC funding
  - SMEs will be recruited from California Coastal Conservancy, SF Estuary Institute, Smithsonian Institute, US Army Corps of Engineers & private firms

**PROJECT DURATION - 2 years**

**AWARD AMOUNT - \$159,900    PORT MATCH - \$80,000**





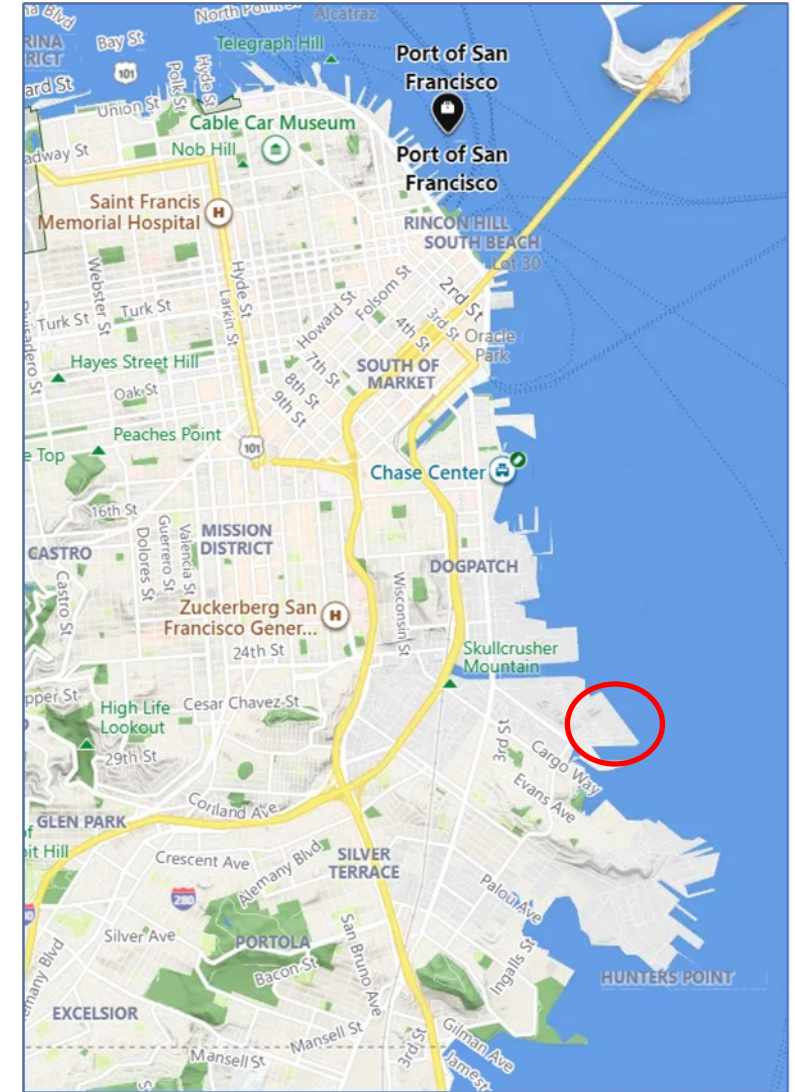
# Federal Emergency Management Agency Hazard Mitigation Grant Program (HMGP)

## PROJECT SCOPE

- Improve seismic stability of Pier 94/96 Marine Terminal
  - Pier 94/96
    - Constructed in 1960's – legacy cargo and heavy maritime use pier
    - Important source of diverse local jobs
    - Critical deep water maritime facility for disaster response
  - Assess and investigate current site conditions
  - Develop earthquake risk assessment and technical report
  - Design up to 60% and prepare environmental approvals

**PROJECT DURATION - 32 months**

**AWARD AMOUNT - \$2,700,000 PORT MATCH - \$900,000**



# Environmental Protection Agency

## Clean Ports Program

*Joint project between San Francisco Bay Ferry, SFPUC, and Working Waterfront Coalition to fund first zero-emission high speed ferry network in the country.*

### PROJECT SCOPE

- A new ferry terminal in Mission Bay equipped with electric charging infrastructure
- Electric charging infrastructure at the Downtown San Francisco Ferry Terminal
- A 400-passenger zero-emission ferry
- Support for a regional maritime workforce development program

**PROJECT DURATION - 36 months**

**AWARD AMOUNT - \$55.3M**

**MATCH - \$15.5M**

## State Vocational Rehabilitation Services Program



### Overview:

- **Grant Summary:** Provide vocational assessments, situational assessments, work adjustment and employment services for adults with severe mental illness through cooperative contract agreement with 5 providers
- **Funder:** US Department of Education (DOE), through the CA Department of Rehabilitation
- **Amount:** \$791,433
- **Timeline:** July 1, 2025 – June 30, 2028

## STD Prevention and Control for Health Departments



### Overview:

- **Grant Summary:** Continue STD Prevention and Control for Health Departments (PCHD) funding, which supports disease investigation for HIV and sexually transmitted infections (STI)
- **Funder:** Centers for Disease Control and Prevention (CDC)
- **Grant Increase Amount:** \$1,212,299
  - Total award: \$13,635,302
- **Timeline:** January 1, 2019 – February 28, 2026

## NIDA Clinical Trials Network: Big South/West Node



### Overview:

- **Grant Summary:** Determine the efficacy of a combination of extended-release injection medication compared to placebo injections for the treatment of cocaine use disorder
- **Funder:** National Institutes of Health (NIH), through the University of Texas Southwestern Medical Center
- **Timeline:** March 1, 2024 – February 28, 2025
- **Grant Increase Amount:** \$13,431
  - Total award: \$104,508

# Comprehensive Opioid, Stimulant, and Substance Use Site-Based Program



### Overview:

- **Grant Summary:** Create Overdose Fatality Review with OCME and other City partners, which will 1) review overdose fatality data, 2) increase collaboration with City partners, and 3) identify additional ways to prevent overdoses
- **Funder:** US Department of Justice (DOJ)
- **Amount:** \$1,600,000
- **Timeline:** October 1, 2024 – September 30, 2027



# Recreational Trails Program Grant

## Twin Peaks Promenade

**Grant Award:** \$1,493,692

**Purpose:**

- Build new recreational trails
- Connect to regional trail systems.

**Grant Administration:**

- Federal Highway Administration via California State Parks Department.

**Grant period:**

- Sept. 24, 2024 through March 15, 2027.

**Grant Funds support:**

- Construction of Twin Peaks Promenade
- Support delivery of larger project that includes renovation of three park trails.

**Grant Requirements:**

- Trail must remain public open space permanently.
- Federal compliance and 48.32% matching funds required.



# Priority Conservation Area Grant

## Visitation Avenue Pedestrian and Bicycle Safety Improvement Project.

**Grant award:** \$750,000

**Purpose:**

- Build new bicycle and pedestrian facilities in Priority Conservation Areas.
- Reduce vehicle trips through improved connectivity.

**Grant Administration:**

- Federal Highway Administration via Metropolitan Transportation Commission

**Grant period:**

- Contract execution through 2029

**Grant Funds Support:**

- New sidewalks and bike lanes on Visitation Avenue (McLaren Park).
- Multiuse path connecting Herz Playground and future links to Sunnydale.

**Grant Requirements:**

- Federal environmental and procurement compliance
- 11.47% matching funds

### CalAIM Justice Involved PATH Round 2 Funding



#### Overview:

- **Grant Summary:** Funds process, protocol and system improvements to facilitate the Medi-Cal enrollment of justice involved individuals transitioning back into the community
- **Funder:** California Department of Health Care Services
- **Amount:** \$223,673
- **Timeline:** May 26, 2023 - October 31, 2024

## Refugee Support Services Funding



### Overview:

- **Grant Summary:** Funds linkages to public benefits, housing assistance, and employment services for refugee clients
- **Funder:** Federal Office of Refugee Resettlement
- **Amount:** \$832,804
- **Timeline:** October 1, 2023 – September 30, 2026
