8 WHEREAS, Ingerson Avenue is the name of the public right-of-way in the sector of the
9 city; and

10 WHEREAS, Ingerson Avenue is where an energetic, selfless, and compassionate
11 twelve-year-old Jesai Kingston Andrews and his family has lived for almost two decades; and

12 WHEREAS, Jesai Kingston was a positive young man with a magnetic personality; and

13 WHEREAS, Jesai Kingston excelled in the sciences, mathematics, as well as athletics;

15 WHEREAS, Jesai Kingston believed in teamwork, his compassionate and selfless
16 character showed when running back to cross the finish line together with his teammates in
17 cross-country; and

18 WHEREAS, Jesai Kingston embraced his leadership roles on and off the field, and at
19 school, he loved being a big brother and role model to his three-year-old brother the most;

21 WHEREAS, Jesai Kingston took pride in being a steward of his community, he often
22 assisted his father in beautifying the community through trimming the hedges, cutting the

2 throughout the year, and distributed resources during the pandemic for free, community

5 skills on Ingerson Avenue during zoom recess, a native son and future leader was lost; now,
6 therefore, be it

7 RESOLVED, That in order to publicly recognize the legacy of Jesai Kingston, there
8 shall be an honorary naming of “Jesai Kingston Way” on Ingerson Avenue between 3rd Street
9 and Griffith Street to enshrine his legacy, and to mark his infinite effect on the community that
10 helped mold his magnanimous character; and, be it

12 honorary street name to its official list of Commemorative Street Names in accordance with
13 Public Works Code, Section 789 et seq.
