4 **against the City and County of San Francisco for \$40,000; the lawsuit was filed on April**
5 **10, 2023, in San Francisco Superior Court, Case No. CGC-23-605730; entitled Ralph**
6 **Bower, et al. v. City and County of San Francisco; the lawsuit involves alleged personal**
7 **injury on a City street.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Ralph Bower, et al. v. City and County
12 of San Francisco, San Francisco Superior Court, Case No. CGC-23-605730 by the payment
13 of \$40,000. The lawsuit involves alleged personal injury on a City street.

14 Section 2. The above-named action was filed in San Francisco Superior Court on April
15 10, 2023, and the following parties were named in the lawsuit: Plaintiffs Ralph Bower,
16 Veronica Fulton, Aidan Gauper and Cory Maryott; Defendant City and County of San
17 Francisco. This is a partial settlement of the case involving Plaintiff Veronica Fulton only.
