In accordance with the Department of Public Works' Order No. 179,195 a copy of which is in the Clerk of the Board of Supervisors File No. \_\_10530 \_\_\_ and incorporated herein by reference, Board of Supervisors Ordinance No.1061, entitled "Regulating the Width of Sidewalks," a copy of which is in the Clerk of the Board of Supervisors

Book of General Ordinances, in effect May 11, 1910, is hereby amended by adding thereto a 1 2 new section to read as follows: Section 1589. The official sidewalk width on south side of Harrison Street between Fremont and 3 4 Beale Streets shall be as shown on Department of Public Works drawings Q-20-695, copies of which 5 are in the Clerk of the Board of Supervisors File No. 6 Section 4. Bruce D. Baumann & Associates, as is necessary as a result of this 7 Ordinance, shall make arrangements with public utility companies and City Departments for 8 the relocation, modification, or any affected public facilities.
