[Declaring the City's Intention to Appropriate Available Rainy Day Reserve Funds to the San Francisco Unified School District – 2011-2012 School Year]

Resolution declaring the City's intention to appropriate available Rainy Day Reserve funds to the San Francisco Unified School District, to help the District cope with the loss of State funding for the 2011-2012 school year.

WHEREAS, Section 9.113.5 of the City Charter establishes a "Rainy Day Reserve," which provides, in part, that the City may withdraw funds from the Reserve for the benefit of the School District in years in which the Controller projects that inflation-adjusted per-pupil revenues for the District will be reduced, and the District has noticed a significant number of layoffs; and,

WHEREAS, If the Controller certifies that these triggers are met, the Mayor and the Board of Supervisors may, in their discretion, appropriate funds from the Reserve to the School District to offset the costs of maintaining education during the upcoming budget year, provided, however, that such appropriations may not exceed the dollar value of the total decline in inflation-adjusted per-pupil revenues for the year, or 25 percent of the Reserve balance, whichever is lower; and,

WHEREAS, based on the Governor's proposed budget, the School District will suffer a loss in revenue, and the School District will need to notice layoffs to teachers, principals, and others, administrators, paraprofessionals, and child development staff due to these cuts; and,

WHEREAS, The Controller is likely to certify that the City may withdraw approximately \$8.35 million from the Rainy Day Reserve for the benefit of the School District for Fiscal Year 2011-2012 and,

WHEREAS, It is the intent of the City and County of San Francisco to approve the appropriation of these funds in the City's 2011-2012 budget and to provide the School District with the funds on July 1, 2011 to prevent devastating financial burden on the schools; and,

WHEREAS, The Controller and the School District will reconcile any differences in the funding allocation based on the final approved Governor's budget; now, therefore, be it

RESOLVED, That the City and County of San Francisco intends to appropriate available Rainy Day Reserve funds to the San Francisco Unified School District for Fiscal Year 2011-2012, to help the District deal with the devastating budget cuts anticipated for the upcoming school year; and be it

FURTHER RESOLVED, That the City and County of San Francisco is proud of the City's leadership and the voting public for ensuring that the City's public schools are supported.
