Sciences; (b) the governance structure of the Asian Art and Fine Arts Museums, War Memorial and Academy of Sciences, oversight of the governing boards over museum operations and finances, and accountability of the governing boards to the City; and (c) efficient management of General Fund-supported operations, and opportunities to redefine the role of the City General Fund in supporting day-to-day operations.
