[Executive Committee of the Corrections Partnership for Criminal Justice Realignment Appointment]

Resolution appointing the San Francisco Department of Public Health to the Executive Committee of the San Francisco Community Corrections Partnership for the purpose of developing an implementation plan for criminal justice realignment.

WHEREAS, Section 33 of AB 117 amends the California Penal Code in Section 1230.1(a) and 1230.1(b) by establishing an Executive Committee of the Community Corrections Partnership, whose responsibility is to develop a plan for the implementation of the 2011 criminal justice realignment; and

WHEREAS, pursuant to 1230.1(b), the membership of this Executive Committee shall consist of the chief probation officer of the county as chair, a chief of police, the sheriff, the district attorney, the public defender, the presiding judge of the superior court, or his or her designee, and one department representative from the county department of social services, the county department of mental health, or the county department of alcohol and substance abuse programs; and

WHEREAS, the County Board of Supervisors shall appoint the department representative from the county department of social services, the county department of mental health, or the county department of alcohol and substance abuse programs; and

WHEREAS, the San Francisco Department of Public Health manages the city and county's behavioral health care system and administers health care services in San Francisco county jails; therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco appoints a representative from the San Francisco Department of Public Health to sit on the Executive Committee of the Community Corrections Partnership for purposes related to the development of the 2011 criminal justice realignment implementation plan.
