WHEREAS, Abraham Pedicabs LLC, dba Cabrio Taxi ("Cabrio Taxi") is a State of California Limited Liability Corporation that operates pedicabs in San Francisco; and.

WHEREAS, Cabrio Taxi was issued License Number 14971 by the Port of San Francisco on May, 1 2011 to operate on its property; and,

WHEREAS, Section 39.09 of the Police Code states that permittees issued pedicab permits pursuant to the provisions of Article 39 shall file with the Board of Supervisors the fares per passenger charged for each trip; and,

WHEREAS, Section 39.09 further states that the Board of Supervisors may adopt. modify or reject the fare schedules submitted; and,

WHEREAS, Cabrio Taxi has filed a fare schedule with the Board of Supervisors, as required under Section 39.09 of the Police Code; and,
