WHEREAS, The Public Library serves the City and County of San Francisco, a highly urban and diverse area; and

WHEREAS, San Francisco is home to 139,630 elementary through college age young people ages 6-24; and

WHEREAS, Twenty-seven percent of children live with a high school dropout, fifty-six percent of families with children are Hispanic and Asian/Pacific Islanders, and twenty-four percent of the City's children are in single parent households; and

WHEREAS, This combination of factors indicates a need for out-of-school-time homework support for San Francisco students; and

WHEREAS, The Public Library has a goal of supporting student success; and WHEREAS, The grant does not require an ASO amendment; and

WHEREAS, The California State Library requires that all indirect costs not be allowed and must be provided in-kind by the recipient library; now, therefore, be it

RESOLVED, That the Public Library accept and expend a grant in the amount of \$20,000 from the California State Library as part of the Federal Library Services and Technology Act (LSTA) to provide out-of-school-time homework support for San Francisco students; and be it

FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget.
