WHEREAS, The Department of Public Health has responsibility for providing primary health and prevention care to residents of San Francisco living with HIV/AIDS; and

WHEREAS, The Department conducted a Request for Proposals for rent subsidies services for San Franciscans living with HIV/AIDS which resulted in the selection of the San Francisco AIDS Foundation for award of a contract;

WHEREAS, The Department requests approval of the contract for a term of five years for the period of July 1, 2011, through June 30, 2016, in the total amount of \$19,685,910, with five additional one-year options to renew the contract, as allowed for in the Request for Proposals; and

WHEREAS, Chapter 9.118 of the San Francisco Charter states that contracts requiring anticipated expenditures of over \$10 million must be approved by the Board of Supervisors; and

WHEREAS, The Department of Public Health estimates that the annual payment of this contract may be increased over the original contract amount, as additional funds become available between July 1, 2011 and the end of the contract term, with five additional one-year options to renew; and

WHEREAS, a copy of this contract is on file with the Clerk of the Board of Supervisors in File No. 110664, which is hereby declared to be a part of this resolution as if set forth fully herein; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby authorizes the Director of Public Health and the Office of Contract Administration/Purchaser, on behalf of the City and County of San Francisco, to execute a contract with San Francisco AIDS Foundation for the provision of rental subsidy services to residents of San Francisco living with HIV/AIDS for the period of July 1, 2011 through June 30, 2016; and, be it

FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the Director of Public Health and the Office of Contract Administration/Purchaser to make amendments to this contract, as needed.
