3 **Resolution approving the City and County of San Francisco 2011 grant application for**
4 **the United States Department of Housing and Urban Development Continuum of Care**
5 **Programs and fulfilling the San Francisco Board of Supervisors review and approval**
6 **process for all annual or otherwise recurring grants of \$5,000,000 or more.**

8 WHEREAS, Under the Department of Housing and Urban Development 2011 grant
9 application for Continuum of Care programs, the City and County of San Francisco and
10 eligible nonprofit entities are eligible to submit funding applications to assist the homeless;
11 and

12 WHEREAS, Under the San Francisco 2010 Continuum of Care application,
13 San Francisco and its nonprofits were awarded \$19,743,334 based on a very strong
14 and competitive grant application; and

15 WHEREAS, HUD announced on August 31, 2011, its 2011 Continuum of Care
16 program requirements and guidelines, including an estimated deadline of October 28, 2011
17 for submittal of grant applications; and

18 WHEREAS, The San Francisco Local Homeless Coordinating Board (LHCB) serves as
19 the legal entity that oversees the Continuum of Care process and programs, including the
20 creation of program priorities, funding categories, application guidelines, and scoring tools;
21 and

22 WHEREAS, The LHCB expects to submit the consolidated application for
23 approximately \$18,365,465 of which a portion of those which passes through the Department
24 of Human Services is greater than \$5,000,000; and

1 WHEREAS, The LHCB has been meeting regularly to better understand the Continuum
2 of Care process and programs, including receiving community input and participation in the
3 development of program priorities, application scoring criteria, application guidelines, and
4 process; and

5 WHEREAS, The LHCB with community input and advice, approved a 2011 application
6 process, scoring criteria, and funding priorities for the 2011 application; and

7 WHEREAS, The 2011 application process established funding categories that include
8 Permanent Supportive Housing, Transitional Housing, Safe Haven, and Supportive Services;
9 and


10 WHEREAS, Under San Francisco Ordinance 265-05, the appropriate City department
11 shall submit a resolution articulating its grant application as well as funding categories to the
12 Board of Supervisors for all annual grant applications of \$5,000,000 or more; now, therefore
13 be it

14 RESOLVED, That the San Francisco Local Homeless Coordinating Board and the
15 Department of Human Services are authorized to submit a 2011 Continuum of Care
16 application; and be it

17 FURTHER RESOLVED, That the San Francisco Board of Supervisors will provide a
18 timely review and approval of the 2011 Continuum of Care application with recognition that
19 such application at the time of the Board review and approval will include funding categories
20 and general description of the application.
