12 November 19, 2012 or for the tenure of the supervisor who nominated the member, whichever
13 is shorter in duration.

14 Bert Hill, seat 7, succeeding himself, term expired, must be a nominee of District 7
15 Supervisor. The member shall serve the unexpired portion of a two-year term ending
16 November 19, 2012 or for the tenure of the supervisor who nominated the member, whichever
17 is shorter in duration.

18 Rachel Ebor, seat 9, succeeding herself, term expired, must be a nominee of District
19 9 Supervisor. The member shall serve the unexpired portion of a two-year term ending
20 November 19, 2012 or for the tenure of the supervisor who nominated the member, whichever
21 is shorter in duration.

22 Casey Allen, seat 11, succeeding himself, term expired, must be a nominee of District
23 11 Supervisor. The member shall serve the unexpired portion of a two-year term ending
24 November 19, 2012 or for the tenure of the supervisor who nominated the member, whichever
25 is shorter in duration.
