9 Section 1. The City Attorney is hereby authorized to settle the actions entitled Julio

11 Construction Company, et al., San Francisco Superior Court, Court Nos. CGC-08-479969 and
12 CGC-10-497921 by the payment of \$75,000.

13 Section 2. The above-named actions were filed in San Francisco Superior Court on
14 September 18, 2008 and March 19, 2010, and the following parties were named in the
15 lawsuit: Plaintiff Julio Calero and Defendants City and County of San Francisco, Rafael Ibarra
