12 underserved communities through community engagement; and,

13 WHEREAS, As a condition of receiving the grant funds, San Francisco Foundation
14 requires the City to enter into an agreement (the "Agreement"), a copy of which is on file with
15 the Clerk of the Board of Supervisors in File No.111011; which is hereby declared to be a part
16 of this resolution as if set forth fully herein; and,

17 WHEREAS, This grant does not require an ASO amendment because no staffing costs
18 are involved; and,

19 WHEREAS, Health Care Services Master Plan Community Stakeholder Interviews
20 grant does not contain indirect costs in order to maximize the use of grant funds on direct
21 services; now, therefore, be it

22 RESOLVED, That DPH is hereby authorized to accept and expend a grant in the
23 amount of \$20,000 from San Francisco Foundation; and, be it




