Resolution authorizing the Port of San Francisco to accept and expend a grant in the amount of \$90,000 from the State of California Coastal Conservancy, through the Association of Bay Area Governments Bay Trail Program, for the Pier 43

[Accept and Expend Grant - Pier 43 Promenade Bay Trail Extension - \$90,000]

Promenade Bay Trail Project in Fisherman's Wharf.

WHEREAS, the Pier 43 Promenade Bay Trail Project is a two block extension of The Embarcadero Promenade and a heavily traveled segment of the "Bay Trail", which is a continuous 400-mile network of trails intended to provide connections to existing park and recreation facilities, create links to existing and proposed transportation facilities, and be planned in a way as to avoid adverse effects on environmentally

WHEREAS, the Project is an identified public access component of the Port's Waterfront Land Use Plan and Waterfront Design & Access Element; and,

WHEREAS, the San Francisco Bay Conservation and Development Commission has issued permits for approval of the Project; and,

WHEREAS, the San Francisco Bay Trail Project is a program administered by the Association of Bay Area Governments (ABAG), designed to provide funding to accelerate the development of the Bay Trail; and,

WHEREAS, the San Francisco Bay Trail Project has found the Pier 43
Promenade Bay Trail Project, a spine of the Bay Trail, eligible for grant funds in the amount of \$90,000 from the Proposition 84 program, which it administers to construct segments of the Bay Trail; and,

sensitive areas; and,

WHEREAS, on January 11, 2011, through Resolution 11-03, the Port
Commission authorized Port staff to accept and expend the Association of Bay Area
Governments, Bay Trail Link Program funds; and,

WHEREAS, In order to receive the grant funds, the Port is required to enter into an agreement with ABAG to accept and expend the grant funds pursuant to certain terms and conditions including the Port's commitment to indemnify ABAG, the Bay Trail Project, and the State of California from any claims or liabilities arising from the grant agreement; and,

WHEREAS, ABAG did not require a cash or 'in kind' match; and,

WHEREAS, This grant does not create any new positions, and will not require an amendment to the Annual Salary Ordinance; and,

WHEREAS, All ABAG grant funding will go toward the development of Pier 43
Promenade Bay Trail Project; and, therefore, be it

RESOLVED, That the Board of Supervisors hereby authorizes the San Francisco
Port Commission to accept and expend \$90,000 in grant funding from the Proposition
84 program to construct segments of the Bay Trail; and be it

FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the Executive Director of the Port or her designee to execute any documents required to enter into this grant, including any amendments, augmentations or extensions thereto and indemnify the Association of Bay Area Governments for liability associated with the activities funded through this grant to the extent approved by the City's Risk Manager, if required by the granting agency.
