[Changing the Street Name of a Portion of La Playa to Great Highway]

Resolution authorizing a street name change on a portion of La Playa Street between Lawton Street and Kirkham Street to "Great Highway" to correct a discrepancy in dual street names and eliminate confusion in delivering public services.

WHEREAS, Residents have brought to the City's attention the problems stemming from dual street names on the 1500 block of La Playa Street and Great Highway, between Lawton and Kirkham Streets. The problems include disruptions to mail and billing services, among other inconveniences in public services; and

WHEREAS, The Department of Public Works, in full compliance with its regulations on street name changes, conducted its investigation on a street name change for La Playa Street between March 1 and March 31, 2011. Results of such investigation are on file with the Clerk of the Board of Supervisors in File No. _____, and are incorporated herein by reference; and

WHEREAS, The Department of Public Works, on behalf of the City, properly posted the street area subject to this street name change for the specified time period in compliance with California Streets and Highways Code Section 970.5; now, therefore, be it

RESOLVED, That consistent with Public Works Code Sections 423, California Government Code Section 34091.1 and California Streets and Highways Code Sections 970.5 and 5026, the San Francisco Board of Supervisors hereby changes the name of La Playa Street between Lawton Street and Kirkham Street to "Great Highway" to correct the discrepancy in dual street names; and, be it

FURTHER RESOLVED, That the Board of Supervisors, in accordance with Transportation Code Section 2.2, directs the Municipal Transportation Agency to prepare

street signs indicating both the new and former names of the street, with the new name "Great Highway" in large letters, and the old name "La Playa" in smaller letters above or beneath the new name; and, be it

FURTHER RESOLVED, That in adopting this legislation, the Board of Supervisors does not intend to effectuate any change in City department jurisdictional control over the subject portion of La Playa Street to be known as Great Highway; and, be it

FURTHER RESOLVED, That the Board of Supervisors directs the Clerk of the Board to promptly forward a copy of this Resolution to the County Surveyor in accordance with California Streets and Highways Code Section 5026.



As a 20 year resident of 1546 Great Highway #44, San Francisco, I am writing to strongly urge you to correct the street name. The discrepancy with my street address "Great Highway" being changed to "La Playa" has caused me to not get my mail and other confusions.

Just this week, I ordered a new cell phone over the phone. Everything went through and then the next day, I received an email telling me that my order was cancelled. There was no specific reason given, so I called. It took me an hour and a half, with being on hold and talking to 5 different people before I was given the reason my order was cancelled. I had given the wrong street address to what they had on file. The person who took the order did not tell me.

Then because my order was cancelled, I had to go to the phone store in person and get the new phone. This transaction took over an hour.

I have also had problems when ordering on the internet. Some months ago, I ordered a plane ticket online and typed in my address and hit return "Great Highway" automatically changed to "La Playa." At some point this might cause other problems, because all of my IDs say "Great Highway."

This kind of discrepancy is aggravating and big waste of time. It has to stop! Please restore the correct name on the 1500 block of "Great Highway" now. Thank you.

As I once again for perhaps the five hundredth time explain why my address is 1576 Great Highway and not 1576 La Playa, I am just so frustrated. If you stand in front of my home as I have for nearly two decades one can see by looking south that that there is no reason for the street name to change at the corner of Lawton and Great Highway. There is no curve, medium or extra lanes that would indicate a new street. Turning one's head or what the heck, maybe walking on down the street one sees that the situation is quite different at the corner of Kirkham and Great Highway. At La Playa, the street curves and obviously becomes two streets the one Great Highway the other La Playa. Now I know it may seem a little simplistic to actually look at the geography one is discussing when one can go to old documents and computer databases, but I would ask that we do exactly that because that is what the city did when putting up street signs and determining what to write on notices posted on our block.

This whole thing began when the USPS installed a new zip code database, we began getting mail for La Playa...at first I thought I could merely call and inform the post office that the street was in fact Great Highway. I did so and didn't think any more about it until I and every other person in my building received a letter from the post office threatening to discontinue mail delivery of any items addressed to Great Highway after ninety days. Imagine my surprise, this person not only did not care that I was being inconvenienced every time I needed to use a credit card online and in many other ways...no the USPS had decided that not only were they not going to simply have a data entry person make the correction, they were going to re-name one of the most famous streets in San Francisco. It has continued to amaze me as this has gone on. The only person who has ever been helpful or indeed human throughout this is Carman Chu. It is my hope that the Board of Supervisors will follow her lead in helping me and my neighbors end this long running Monty Pythonesque comedy...Please call it Great Highway, it always has been.

To the San Francisco Department of Public Works,

Thank you for giving the residents of the 1500 block of Great Highway an opportunity to "address" this issue. My family and I have lived at 1576 Great Highway since 1988, 23 years. To clarify here at the outset, there has never been confusion as to the name of our street, or where our homes were located. It has <u>always</u> been known as "Great Highway" throughout the years.

About two years ago, when we started receiving mail, generally computergenerated junk mail addressed "1576 La Playa", we thought it was an odd coincidence and strange mistake by the postal carrier. But as the "oddity" continued, it has grown into a frustratingly substantial problem that has included both financial and legal issues. Multiple conflicting address identifiers have created unnecessary and difficult problems, such as processing personal loans, confirming credit, ordering on-line, etc.; anything and everything dealing with personal identification. All of this because of a mistake made on an assessor's map years ago — a mistake that continues to cause these identity related problems to this day. A mistake being unduly perpetuated.

In early attempts to rectify the situation with the USPS, their original response to our problem was a literal threat — to stop delivery of all mail addressed to "Great Highway" and force us to accept an arbitrary street name change. Their attitude if not obnoxious was priceless, that we had simply on a whim decided to identify our street as "Great Highway". Thanks again to Supervisor Chu for intervening on our behalf to confirm with the post office that the residents do in fact know the addresses of their own homes and hadn't begun some sort of re-naming revolution...

Their next response was thoughtless and sad. The attitude then was, that it would be easier for a city block worth of people to go about changing their lives, licenses, credit, business, etc., than to approach the city about a solution that would help the residents. The expectation of that large tedious, unnecessary effort of citizens versus the few keystrokes it took a data entry employee a few seconds to make. Disappointing.

This issue is mistakenly couched as a "longstanding discrepancy". As stated above, prior to two years ago, there had never been any confusion as to the name of this block; it has always, historically been "Great Highway". No one would understand what was meant if you mentioned street name confusion. The only real confusion as to our street name is with the USPS' computer zip code database. There is no record of confusion or debate; confusion was only introduced with the use of the new database.

Let me add what I think are a few pertinent points. Assessors' maps from the turn of the 19th century, when our neighborhood was still referred to as "Carville" have the block labeled as "Great Highway". In fact, early in the century, a "La Playa" street south

of Golden Gate Park ends with Judah Street as its southern terminus. San Francisco maps and city guides through the 20th century make no confusion about the difference between the 1500 block of Great Highway and the nearby La Playa Street. Maps and guides label the 1500 block of Great Highway as exactly that – "Great Highway".

There has never been a recorded, formal, official re-naming of our block from "Great Highway" to "La Playa" by the city. I assume that post office zip code computer protocols don't take precedence over such city government business. And I reiterate, there has been no confusion, no "La Playa issue" until the post office ran with the map error two years ago.

The concrete imprints placed in the sidewalk by Public Works have always appeared as "Great Highway" at both the Kirkham and Lawton ends of the block, as well as "Great Highway" street signs. The concrete imprint at the contested Great Highway/Kirkham corner is many years old – defying any conception of long standing mix-up. And only until early last year was a La Playa sign put up alongside an existing Great Highway street sign at the north end of the block.

La Playa street comes to an end, its south terminus being the cross street of Kirkham. Physically, Great Highway continues northbound to Lincoln Street, while La Playa branches off <u>from</u> Great Highway, as well going northbound to Lincoln. At the Kirkham intersection northbound, there is a physical island separation between Great Highway and La Playa, identifying separate streets. This coincides with the separation of the 1400 block of La Playa from the 1400 block of Great Highway. But once past the cross street of Kirkham southbound, there is no physical island separation, no parallel rows of homes, simply painted lines that guide merging and separating traffic. There is no spurious "merging streets" confusion. To look out of our window, you would see no difference in our block from the view you would get between Lawton and Moraga, Moraga and Noriega, and so on along Great Highway. To stand in the middle of the street and look north and south provides a geographic obviousness that this block offers no remarkable distinctions that would lead one to believe that it is anything but the Great Highway.

As a native San Franciscan and amateur historian of the area, I can report an historical romance and cache to the street known as Great Highway. It is also the home we have known for so many years. It is important once and for all to end the perpetuation of this error that has unnecessarily introduced the "La Playa" confusion and burden into our lives.



In response to the above request, Taraval Captain Curtis Lum sent an email to approximately 1500 residents in the affected area seeking input, issues and/or concerns about the suggested name change.

To date, there have been four responses; three against and one in favor. One of those against the name change is employed as a dispatcher for a private ambulance company. The concern is there will be three parallel highways in the same vicinity with very similar names; Great Highway, Lower Great Highway, and Upper Great Highway, which may lead to confusion during emergencies which could possibly result in an increase in response times.

However, it is the opinion of the San Francisco Police Department that the name change will not increase confusion; therefore, there is no objection on the part of the Police Department.


Written comment from Ellen Koivisto:

The building that I live in, 1556 Great Highway, has been on Great Highway since the 1960's for certain (as testified to by the owner, Freda Lutz at 650/873-7887). When we moved in twenty years ago, our lease said Great Highway (Gaetani Realty, ref. Noel at 668-1202), all our utilities and phone hook-up were Great Highway, and so all our personal and business information was changed to Great Highway, too: medical insurance, credit cards, etc.


Then suddenly, in 2008 and without any warning whatsoever, the postal service decided to change our block to La Playa without telling anyone. Suddenly, our junk mail was addressed to La Playa, and people weren't getting packages they'd ordered for Great Highway. This, despite a postal service address code affixed to the front door of our building (that they subsequently tore off after I sent in letters of complaint about the address change):



the street sign at the end of the block:



the physical realities of the block (where La Playa merges into Great Highway within two houses on our block):



and the decades of it being Great Highway.

This has created a terrible situation for the residents here and, given that this block has approximately 100 rental units on it, this situation affects a large number of people. Therefore I strongly urge you to finally, legally, assign us the name we've had all along – Great Highway – and right the record for all of us.

Regarding:

<u>File No. 110968.</u> Resolution authorizing a street name change on a portion of La Playa Street between Lawton Street and Kirkham Street to "Great Highway" too correct a discrepancy in dual street names and eliminate confusion in delivering public services.

My name is Raymond Stuart, I am a retired C&C of S.F. Medical Social Worker and I have resided at 1556 Great Highway (La Playa) since September of 1989. This address is located on the block that is being considered for an official name change to "Great Highway". Until March of 2008 all of my mail was delivered to that address on the "Great Highway".

I strongly support the Land Use & Economic Development Committee authorization of the proposed change in naming of the street between Lawton Street and Kirkham Street to "Great Highway".

I submit the following reasons for my support of that change and would hope that those reasons are also found to be compelling by the Land Use & Economic Development Committee to authorize the name change:

- 1. A long-term precedent has been established by the U. S. Postal Service regarding delivery of mail to the "Great Highway" addresses on that block (as well as PG&E, and AT&T both at billing to that address)
- 2. The USPS changing the mailing address to "La Playa" will create confusion amongst those who mail to those addresses (note: USPS has agreed to mail to both street name addresses until the issue is settled)
- 3. Changing the address will create an environment ripe for identity theft opportunities

- 4. C&C of S.F. street signs and embossed sidewalk signs clearly indicate that the C&C of S.F. recognizes the street portion in question as "Great Highway"
- 5. There is no compelling need for the USPS to change the mailing address to "La Playa" i.e., there is no need to "fix something that is not broken"
- 6. The USPS's need to update their computer system is not compelling reason to disrupt the lives of S.F. residents, create opportunities for identity theft or ignore precedent. The USPS can just as easily update their computer data base with the name "Great Highway".

I thank you very much for your attention in this important matter.
