1	[California Constitution Appropriations Limit for FY2011-2012]

3	Resolution establishing the appropriations limit for FY2011-2012 pursuant to California
4	Constitution Article XIII(B).
5	
6	WHEREAS, Article XIII B of the California Constitution provides that the annual
7	appropriations of the City and County of San Francisco which are subject to said Article may
8	not exceed the Appropriations Limit for the prior year, with adjustments as provided in said
9	Article XIII(B); and
10	WHEREAS, The California Government Code, Section 7901, defines the terms, and
11	Section 7902(b) sets forth the equations to be used to determine the City and County of San
12	Francisco's annual Appropriations Limit, according to the following formula:
13	"(b) For FY1981-1982 and each year thereafter, the appropriations limit of the state
14	and each local jurisdiction shall equal the appropriations limit for the prior fiscal year
15	multiplied by the lesser of the change in cost of living for the calendar year in which the
16	fiscal year begins or the change in California per capita personal income for the
17	calendar year preceding the beginning of the fiscal year for which the appropriations
18	limit is to be determined, the product multiplied by the change in population of the local
19	jurisdiction for the calendar year preceding the beginning of the fiscal year for which the
20	appropriations limit is to be determined, and adjusted for other changes required or
21	permitted by Article XIII(B) of the California Constitution;" and
22	WHEREAS, The resulting calculation establishing the City and County of San
23	Francisco's fiscal year 2011-12 Appropriations Limit is:
24	\$2,441,531,489 X 0.9968 X 1.0100 = \$2,458,087,847; and

1	WHEREAS, For future Appropriations Limit calculations pursuant to said Article, the
2	City will use the gross appropriations limit of \$2,458,087,847; and
3	WHEREAS, This matter has been considered at a regularly scheduled meeting of the
4	Board of Supervisors for the City and County of San Francisco; and
5	WHEREAS, The documentation used to determine the Appropriations Limit for the Cit
6	and County of San Francisco for FY2011-2012 was available for public inspection in the
7	Office of the Clerk of the Board of Supervisors for at least 15 days prior to said regularly
8	scheduled meeting; now, therefore, be it
9	RESOLVED, That the City and County of San Francisco elects to use the local
10	assessment growth due to non-residential new construction and elects to use the annual
11	percent change in population as measured by the San Francisco City and County population
12	growth from the previous year for the purpose of computation of its Appropriations Limit
13	pursuant to Article XIII B of the California Constitution for FY 2011-2012; and, be it
14	FURTHER RESOLVED, That the net appropriations limit for FY 2011-2012 is
15	established at \$2,458,087,847.
