9 approved and said map is adopted as an Official Final Map 6374; and be it

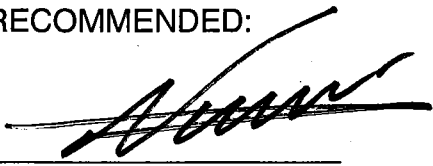
10 FURTHER MOVED, That the San Francisco Board of Supervisors adopts as its own

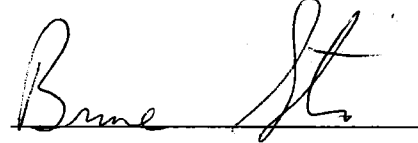
