Resolution authorizing the Office of Economic and Workforce Development to retroactively accept and expend a grant in the amount of \$5,724,203 from the Department of Labor for TransitionSF.

WHEREAS, The Department of Child Support Services (DCSS) currently administers over 16,000 child support cases; of which, over 1,000 involve a non-custodial parent who are not employed, do not have the skills to enter the workforce, and are not meeting their child support obligations as a result; and

WHEREAS, The San Francisco Human Services Agency (SFHSA) has administered the Community Jobs Program (CJP) and Jobs Now that provided transitional jobs for unemployed parents and CalWORKS (TANF) recipients; and

WHEREAS, Goodwill Industries of San Francisco, San Mateo and Marin (GW) was one of two community based organizations contracted to provide transitional employment under the Jobs Now program funded by the Recovery Act; and

WHEREAS, The Office of Economic and Workforce Development (OEWD) staffs the San Francisco Workforce Investment Board and won an Enhanced Job Training Demonstration grant from the Department of Labor as the lead applicant for the TransitionSF program. TransitionSF is a partnership that includes SFHSA, DCSS, GW, Adult Probation, and the San Francisco Sheriff's Department and will provide 500 non-custodial parents with enhanced transitional job services; and

WHEREAS, This grant does not create any new positions as the program activities will be performed by existing staff, and will not require an amendment to the Annual Salary Ordinance; and

WHEREAS, This grant does require any matching funds; and

WHEREAS, The grant budget includes provision for indirect costs of \$42,447; now, therefore, be it

RESOLVED, That OEWD is hereby authorized to accept and expend retroactively a grant in the amount of \$5,724,203, for the period of July 1, 2011 through June 30, 2015; and be it

FURTHER RESOLVED, That OEWD is hereby authorized to retroactively accept and expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and be it

FURTHER RESOLVED, That the Director of OEWD is authorized to enter into the agreement on behalf of the City.
