1 (b) Pursuant to Planning Code Section 302, the Board of Supervisors finds that this 2 ordinance will serve the public necessity, convenience, and welfare for the reasons set forth in 3 Planning Commission Resolution No. <u>18477</u>, and incorporates those reasons herein by reference. A copy of said Planning Commission Resolution is on file with the Clerk of the 4 Board of Supervisors in File No. 110853. 5 The Board of Supervisors finds that this ordinance is in conformity with the 6 (c) 7 General Plan and the Priority Policies of Planning Code Section 101.1 for the reasons set 8 forth in Planning Commission Resolution No. <u>18477</u>, and hereby incorporates those reasons 9 herein by reference. 10 Section 2. The San Francisco Planning Code is hereby amended by amending Section 11 12 429, to read as follows: 13 SEC. 429. ARTWORKS, OPTIONS TO MEET PUBLIC ART FEE REQUIREMENT, **RECOGNITION OF ARCHITECT AND ARTISTS, AND** *MODEL* **REQUIREMENTS IN C-3** 14 **DISTRICTS.** 15 (The effective date of these requirements shall be either September 17, 1985, the date 16 17 that they originally became effective, or the date of a subsequent modification, if any, became 18 effective.) 19 <u>SEC. 429.1. DEFINITIONS</u>. (a) Artworks. In addition to the definitions set forth in Section 401 of 20 this Article, the following definitions shall govern interpretation of Section 429.1 et seq.: "Conservation" shall mean the profession devoted to the preservation of cultural property for 21 22 the future. 23 "Construction Cost" shall be determined by the Department of Building Inspection in accordance with established industry standards or in the manner used to determine the valuation of 24 work as set forth in Section 107.2 of the Building Code. 25

- (a) Installation. The project sponsor must install the public art in compliance with this Section
   (1) in areas on the site of the building or addition so that the public art is clearly visible from the public
   sidewalk or the open-space feature required by Section 138, or (2) on the site of the open-space feature
- provided pursuant to Section 138, or (3) in a publicly accessible lobby area of a hotel ("On-Site Public
  Artwork").

Said *works of art* <u>On-Site Public Artwork</u> shall be installed prior to issuance of the first certificate of occupancy; provided, however, that if the Zoning Administrator concludes that it is not feasible to install the works within that time and that adequate assurance is provided that the works will be installed in a timely manner, the Zoning Administrator may extend the time for installation for a period of not less than 12 months. Said works of art may include sculpture, bas-relief, murals, mosaics, decorative water features, tapestries or other artworks permanently affixed to the building or its grounds, or a combination thereof, but may not

1 include architectural features of the building, nor artwork designed by the architect, except as 2 permitted with respect to the in lieu contribution regarding publicly owned buildings meeting 3 the criteria described above. Artworks shall be displayed in a manner that will enhance their enjoyment by the general public. The type and location of artwork, but not the artistic merits 4 5 of the specific artwork proposed, shall be approved by the Zoning Administrator following a 6 review of the Arts Commission's written report under subsection (b) below in accordance with 7 the provisions of Section 309 of this Code. The term "construction cost" shall be determined in the 8 manner used to determine the valuation of work as set forth in Section 107.2 of the Building Code. 9 (b) Consultation with Arts Commission. Effective on the effective date of this Ordinance No. \_\_\_\_\_, the project sponsor shall provide information to the Arts Commission 10 regarding the type, durability, design, artistic merit, and publicly accessible location of the 11 12 project sponsor's proposed On-Site Public Artwork. Following such consultation and prior to 13 DBI's issuance of the first construction document, the Arts Commission shall provide the 14 project sponsor and Planning Department with a written report summarizing its 15 recommendations regarding the type, durability, design, artistic merit, and publicly accessible location of the On-Site Public Artwork. 1 (a) Installation. The project sponsor must install and complete the final Artwork as 2 provided in Section 429.4(a) and 45% of the remaining amount to the Public Art Trust. These 3 two actions will fulfill the project sponsor's Public Art Fee Requirement under this Section 42.9 and the project sponsor may retain the balance of 5% of the Public Art Fee. 4 (b) Consultation with Arts Commission. Effective on the effective date of this 5 6 Ordinance No. , the project sponsor shall provide information to and consult with the 7 Arts Commission pursuant to the provisions of Section 429.4(b). 8 (c) Administrative Fee. The Arts Commission is authorized to collect an administrative 9 fee from the project sponsor of \$2,500 for administration of this option and, if justified, an 10 additional amount based on a time and materials basis. The administrative fee shall be taken out of the Public Art Fee Requirement, not calculated in addition to the Fee. The Arts 11 12 Commission may adjust the administrative fee annually based on a cost-of-living or similar 13 index. Any such adjustment shall be published on the Arts Commission and Department of Planning websites. 14 SEC. 429.57. ARTS COMMISSION PUBLIC ARTWORK TRUST FUND. 15 (a) All monies contributed to the Public Artwork Trust Fund pursuant to this Section 429 shall 16 17 be deposited in the special fund maintained by the Controller called the Public Artwork Trust under 18 Section 10.100-29 of the Administrative Code, as may be amended from time to time. The receipts in 19 the Trust are hereby appropriated in accordance with law to be used by the Arts Commission within the 20 C-3 District or within a half-mile of the boundary of the C-3 District to enhance the visibility and 21 quality of artworks in the public realm and to improve the public's access and enjoyment of the 22 artworks in the public realm. 23 (b) With the above objective, through a competitive public process the Public Artwork Trust Fund shall be overseen by the Arts Commission and used to fund: (i) the creation, installation, and 24 25 exhibition of temporary and permanent public works of art in the public realm and within the C-3

written notice to the Arts Commission for the Commission's records containing the name of
the artist(s), the title, date and medium of the artwork, a photograph of the artwork, and the
location of the Artwork and address of the building. The Commission staff shall make this
information available to the public in an accessible format, such as through the publication of
a public art map or on its website, and shall update the information regularly.

7 (c) Models. In a C-3 District, in the case of construction of a new building, or any addition in

8 *height in excess of 40 feet to an existing building, two models shall be submitted to the Planning* 

- 9 *Department prior to approval of the project, as follows:*
- 10 (1) One model of the building at a scale of 1'' = 100'; and

11 (2) One model of the block in which the building is located at a scale of 1'' = 32', which model

12 *shall include all the buildings on the block on which the building is located and the streets surrounding* 

13 *the block to the centerline of the streets and shall use as its base the land form starting at sea level;* 

- 14 *provided, however, that if the Planning Department determines that it has an up-to-date model of the*
- 15 *block in which the building is located, only a model of the building shall be submitted.*

16 (d) Procedure Regarding Certificate of Occupancy. The Director of DBI shall provide notice 17 in writing to the Zoning Administrator at least five business days prior to issuing the first certificate of 18 occupancy for any building subject to the provisions of this Section. If the Zoning Administrator notifies 19 the Director of DBI within such time that the provisions of this Section have not been complied with, 20 the Director of DBI shall deny the permit. If the Zoning Administrator notifies the Director of DBI that 21 the provisions of this Section have been complied with or fails to respond within five business days, the permit of occupancy shall not be disapproved pursuant to this Section. The procedure set forth in this 22 23 subsection is not intended to preclude enforcement of the requirements of this Section through any 24 means otherwise authorized.
