3	Resolution approving the Second Amendment to the Refuse Collection Agreement between
4	the City and County of San Francisco and Recology San Francisco, Recology Golden Gate,
5	and Recology Sunset Scavenger, increasing the total not-to-exceed amount of the agreement
6	from \$23,537,527 to \$29,337,527, under Charter Section 9.118(b).
7	
8	WHEREAS, The Board of Supervisors approved Resolution No. 147-07 on March 21,
9	2007, waiving a competitive solicitation process and authorizing a refuse collection agreement for
10	\$23,037,527 with Recology San Francisco, Recology Golden Gate, and Recology Sunset
11	Scavenger with an initial term of 4 years and 3 months, with two one-year options to renew at the
12	Purchaser's discretion; and,
13	WHEREAS, The Office of Contract Administration entered into an Agreement with the
14	Contractor for \$23,037,527, dated April 1, 2007 through June 30, 2011, for refuse collection from
15	City Departments; and,
16	WHEREAS, The Purchaser executed the First Amendment, which did not require Board
17	of Supervisors approval, to the Agreement on July 1, 2011, to exercise the first one-year option
18	period and increase the contract amount by \$500,000; and,
19	WHEREAS, The Agreement is approaching the contract amount of \$23,537,527; and,
20	WHEREAS, The Contractor has agreed to waive its right to a COLA increase during the
21	First Option Period, The Office of Contract Administration and Contractor propose to enter into a
22	Second Amendment to increase the contract's not-to-exceed amount from \$23,537,527 to
23	\$29,337,527; and,

1	WHEREAS, The San Francisco Charter Section 9.118(b) provides that when agreements
2	of \$10 million or more are amended to increase the not-to-exceed amount by \$500,000 or more,
3	then such amendment shall be subject to approval of the Board of Supervisors by resolution; and,
4	WHEREAS, The Agreement and the proposed Second Amendment are on file with the
5	Clerk of the Board of Supervisors in File No, which are hereby declared to be
6	a part of this resolution as if set forth fully herein; now, therefore be it,
7	RESOLVED, That the Board of Supervisors approves the Second Amendment to the
8	contract with Recology San Francisco, Recology Golden Gate, and Recology Sunset Scavenger as
9	described above; and be it
10	FURTHER RESOLVED, That the Board of Supervisors authorizes the Office of Contract
11	Administration to increase the contract amount from \$23,537,527 to \$29,337,527.
