Green Apple Books

Since starting as a temporary employee assisting the bookkeeper in 1993, I quickly progressed through the ranks until I became day-to-day operations manager around 1996. With two partners, I gradually bought the business from the original owner and now serve as CEO and managing partner.

Despite challenges in the book business—from the rise (and partial fall) of big-box superstores to Amazon—Green Apple has remained relevant and thriving through innovation and adaptation under my leadership and direction.

I manage all aspects of this small business, including:

- **Personnel**: I hire and oversee training for our 28 employees and maintain a positive relationship with the union that represents our employees (UFCW, Local 5), including contract negotiations every three years.
- Finance: I manage all aspects of cash flow, financial planning, investment, banking, evaluation of product mix, sales per linear foot, etc.
- **Communications**: I founded our blog; act as primary Tweeter (@greenappleguy); developed our Facebook presence and e-commerce website; write, edit and produce our email newsletter with 7,000 subscribers; serve as liaison to the publishing industry, media, government, community partners, etc.
- **Project management**: when something new comes along, I deal with it. Recent examples include purging a warehouse of 150,000 books via pop-up store; switching point-of-sales system with 12 users for better efficiency; spearheading Groupon and other social media offers; partnering with Sunset district cafes to sell our used books in their cafes, etc.

All these efforts—plus the support of my two partners, our excellent staff, and loyal customers—have kept Green Apple thriving despite the recent economic downturn and a rapidly evolving industry in which so many other bookstores have failed.

Board Service

SFLOMA (San Francisco Locally Owned Merchants Alliance) Co-founder/steering committee member

Around 2005, I helped found this "Local First" organization which strives to identify and promote locally owned business and educate consumers on the economic power of shopping locally. With Hut Landon (NCIBA) and Rick Karp (Cole Hardware), I have helped develop and steer this organization of local business. In 2007, we commissioned an important economic study that showed, in brief, that if San Franciscans shifted 10% of their spending from chains to local businesses, it would create 1,300 new jobs and \$200 million in increased economic activity annually.

NCIBA (Northern California Independent Booksellers Association) Treasurer

Since 2008, I have been a board member of this association, which is staffed by Executive Director Hut Landon and another employee. NCIBA represents nearly 200 indie bookstores in Northern California. We produce a spring gathering, a fall trade show, a holiday catalog with distribution of 250,000+ copies, and represent our member stores in publisher relations, media, etc.

South End Rowing Club Treasurer

Since late 2010, I have served on the board of this truly unique non-profit athletic club, overseeing the club's finances and meeting monthly to address issues ranging from America's Cup 2012-2013 to a planned \$1.2 million expansion and renovation.

Personal

My family is an important part of my life. Since 2000, I have been married to Samantha Schoech, a freelance writer for Sunset magazine, Babycenter.com, etc. We have 5-yearold twins who attended Laurel Hill Nursery School (a co-op that required lots of participation). The kids now attend kindergarten at Sunset Elementary School.

The city of San Francisco is also a passion of mine; I moved here right after graduating from college in 1993, and I am informally involved in many communities that share my interests, from bay swimmers to Lake Merced rowers, Ocean Beach surfers to the SF Parents of Multiples club. I'm a proud member of the SF Bike Coalition and often commute by bike from home to work.

A novel assay is described which allows the entrapment and detection of the immunoglobulin secreted from individual viable hybridoma cells using a secretion capture and reporter web (SCRW). By encapsulating the cells in agarose microdroplets which have been derivatized to create a fluorescent antigen-specific sandwich assay, flow cytometry can be used to identify and sort productive cells from a heterogeneous population. Using agarase, the cells can be recovered from the microdroplets and clonally expanded after selection. The assay has been used to redone rare secretors from hybridoma cultures and to enhance the production of cultures with poor producers. The assay is easily generalized for the detection of any secreted protein for which specific antibodies or other ligands are available.

At least five of the seven individuals appointed to the Commission shall be owners, operators, or officers of San Francisco small businesses. One of the individuals appointed to the Commission may be either a current or former owner, operator, or officer of a San Francisco small business. One member of the Commission may be an officer or representative of a neighborhood economic development organization or an expert in small business finance.
