Section 1. The Board of Supervisors adopts as its own and incorporates by reference herein as though fully set forth the Planning Department findings in its letter dated June 23, 2011. Said letter stated the actions contemplated herein are consistent with the General Plan and in conformance with the Eight Priority Policies of Planning Code Section 101.1. A copy of said letter is in the Clerk of the Board of Supervisors File No. ______111285____. Section 2. In the abovementioned letter, the Planning Department also determined that the actions contemplated in this Ordinance are in compliance with the California Environmental Quality Act (California Public Resources Code Sections 21000 et seq.). Said determination is incorporated herein by reference.

In accordance with the Department of Public Works' Order No. 179,498, a copy of which is in the Clerk of the Board of Supervisors File No. 111285 and incorporated herein by reference, Board of Supervisors Ordinance No.1061, entitled "Regulating the Width of Sidewalks," a copy of which is in the Clerk of the Board of

7	Section 4. The City and County of San Francisco, as is necessary as a result of this
8	Ordinance, shall make arrangements with public utility companies and City Departments for the
9	relocation, and/or modification of any affected public facilities. Any necessary relocation,
10	modification, or both of such facilities shall be at the cost of the owner of the utility.
