

13 and mentors from the San Francisco Unified School District, San Francisco State University,
14 City College of San Francisco, and other colleges in Northern California; and,

15 WHEREAS, Our Kids First is known and respected by many schools and communities

18 programs including after school programs, summer camps, college tours, and career
