



A SIX UNIT (3 RESIDENTIAL AND 3 COMMERCIAL) MIXED-USE CONDOMINIUM PROJECT

The City Planning Department in its letter dated August 19, 2011, stated that the subdivision is in conformity with the General Plan and the Priority Policies of City Planning Code Section 101.1.

The Director of Public Works, the Advisory Agency, acting in concurrence with other City agencies, has determined that said Final Map complies with all subdivision requirements related thereto. Pursuant to the California Subdivision Map Act and the San Francisco Subdivision Code, the Director recommends that the Board of Supervisors approve the aforementioned Final Map.
