[Administrative Code - Board Approval of Grants Over \$100,000]

Ordinance amending the San Francisco Administrative Code Section 10.170-1 to set a threshold of \$100,000 or more for Board of Supervisors approval of the acceptance and expenditure of grants.

Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Administrative Code is hereby amended by amending Section 10.170-1, to read as follows:

SEC. 10.170-1. GRANT FUNDS - ACCEPTANCE AND EXPENDITURE.

(a) Any department, board, or commission that seeks to accept and expend federal, State, or other grant funds must comply with any applicable provisions of this Section.

(b) The acceptance and expenditure of federal, State, or other grant funds in the amount of \$100,000 or more is subject to the approval by resolution of the Board of Supervisors. If, as a condition of the grant, the City is required to provide any matching funds, those funds shall be included in determining whether the grant meets the \$100,000 threshold. ~~or by ordinance as required under subsection (b), in the following manner:~~

(a) The Any department, board, or commission requesting that requests the approval to accept and expend grant funds by the Board of Supervisors shall submit the following documents to the Board prior to its consideration:

1 (1) A proposed resolution approving the acceptance and expenditure of grant
2 funds, or a proposed ordinance as required under subsection (b), signed by the department
3 head, the Mayor or his or her designee, and the Controller;

4 (2) A completed "Grant Information Form." The Clerk of the Board shall
5 prepare the form; it shall include a disability access checklist, indirect cost recovery, and other
6 information as the Board of Supervisors may require;

7 (3) A copy of the grant application;

8 (4) A letter of intent to award the grant or acknowledgment of grant award from
9 the granting agency; and,

10 (5) A cover letter to the Clerk of the Board of Supervisors substantially
11 conforming to the specifications of the Clerk of the Board.

12 (c) Grants of Less Than \$100,000. The Controller may prescribe rules for the acceptance and
13 expenditure of federal, State, or other grant funds in amounts less than \$100,000.

14 (d) ~~(b)~~ Grant Funded Positions. No position funded by a grant, regardless of the
15 amount of the grant, shall be authorized or filled unless the classification, duration, and number
16 of positions to be funded by the grant are specifically set forth in an ordinance approving
17 acceptance and expenditure, which ordinance shall also contain appropriate amendments to
18 the annual salary ordinance to reflect the positions proposed to be funded through the grant.

19 (e) ~~(c)~~ Recurring Grants. Grants that provide funding to departments or programs of
20 the City and County in a recurring manner or continue funding from one year to the next shall
21 be included in the annual budget submission by the Department.

22 The Department budget submission shall also include a budget detail, explanations
23 and substantiations of the grant funding. If it is not possible for the Department to include
24 recurring grant funds in its annual Department budget submission, the acceptance and
25

1 expenditure of a recurring grant shall follow the procedure set forth in paragraph (a) of this
2 Section.

3 ~~(f)~~ **Indirect Costs.** Every grant shall contain provisions for the reimbursement of
4 indirect costs. Such indirect cost provisions shall reimburse the City and County from grant
5 funds for administrative services that are necessary for the administration and performance of
6 the project or program. Every department, office, board or commission shall establish a rate
7 for such indirect costs that is approved by the Controller and fixed in accordance with a
8 directive issued by the Controller. The indirect cost rate shall be included in the grant budget
9 that is submitted to the Board of Supervisors and in the authorizing resolution.

10 The receipt and expenditure of grant funds shall not be approved by the Board of
11 Supervisors unless the Controller has certified that provisions for appropriate indirect cost
12 reimbursement is included in the grant budget.

13 If indirect costs are not allowed by the funding agency, or for other reasons indirect
14 costs cannot be included in the budget, these reasons shall be stated in the authorizing
15 resolution. Upon approving acceptance and expenditure, the Board of Supervisors may waive
16 the requirement for the inclusion of reimbursement of indirect costs.

17 ~~(g)~~ **Grant Budget.** Every department, board, commission, agency, or office
18 submitting a budget for a grant of public funds to the Board of Supervisors pursuant to this
19 Section shall submit such budget in a format that conforms to and provides the detail
20 substantiation that is required of similar appropriations in the annual budget for the City and
21 County. The mission and goals statement, which is required as part of the annual budget, is
22 not required by this Section for submittal of a grant budget.

23 ~~(h)~~ **Grant Budget Revision.** A department, agency, or office may reallocate or
24 transfer funds of line item expenditures within an approved grant budget, if such reallocations
25 or transfers are within the total of the approved budget and are allowed by the granting

1 agency. If any line item of a Federal or State grant is modified or increased by more than 15
2 percent, copies of documentation of such modification or increase which are transmitted to
3 Federal or State agencies shall also be transmitted to the Board of Supervisors.

4 ~~(j)~~ **Grant Draw Down of Funds.** Departments, agencies, boards, and
5 commissions shall promptly draw down grant funds from a Federal, State, or other funding
6 agency and deposit such funds in the Treasury of the City and County of San Francisco to
7 minimize the displacement of City funds that support grant activities.

8 ~~(j)~~ **Grant Transportation Authority.** The provisions of this Section shall not be
9 applicable to applications for or expenditure of funds from the San Francisco County
10 Transportation Authority. The Controller shall prescribe rules for the acceptance and
11 expenditure of such funds.

12 ~~(k)~~ **Certain Transportation Funds (Proposition 1B Funds).** The voters of
13 California adopted Proposition 1B, the Highway Safety, Traffic Reduction, Air Quality, and
14 Port Security Bond Act of 2006, at the November 7, 2006 California General Election. Under
15 the Proposition, the State will appropriate two billion dollars (\$2,000,000,000) into the Local
16 Streets and Road Improvement, Congestion Relief, and Traffic Safety Account of 2006
17 ("Proposition 1B Local Street and Road Improvement Funds"). These funds will be distributed
18 to cities and counties for improvements to transportation facilities that will assist in reducing
19 local traffic congestion and further deterioration, improving traffic flows, or increasing traffic
20 safety that may include, but not be limited to, street and highway pavement, maintenance,
21 rehabilitation, installation, construction and reconstruction of necessary associated facilities
22 such as drainage and traffic control devices, or the maintenance, rehabilitation, installation,
23 construction and reconstruction of facilities that expand ridership on transit systems, safety
24 projects to reduce fatalities, or as a local match to obtain state or federal transportation funds
25 for similar purposes. The Proposition requires that the funds distributed to the City be

1 deposited in a local account that is designated for the receipt of state funds allocated for local
2 streets and roads.

3 (1) The Board of Supervisors finds that while there are a range of projects
4 involving various City departments that could benefit from the Proposition 1B Local Street and
5 Road Improvement Funds, implementing a coordinated planning process for use of those
6 funds will help ensure the effective and efficient expenditure of funds in a manner that will
7 maximize the benefit to the City and its residents.

8 (2) The Board of Supervisors further finds that given the range of projects and
9 the Citywide impact of transportation-related projects, it is appropriate for the Board to review
10 proposed expenditures of Proposition 1B Local Street and Road Improvement Funds, and to
11 be kept apprised of the progress on projects that are receiving Proposition 1B Local Street
12 and Road Improvement Funds.

13 (3) The Board of Supervisors shall not to appropriate any Proposition 1B Local
14 Street and Road Improvement Funds, as referenced above, until the Board has received from
15 the department or departments requesting the appropriations a specific and detailed spending
16 plan for the funds. The Spending Plan (the "Plan") shall set forth projects, programs and
17 other improvements to be funded over the next ten years (10) years by Proposition 1B Local
18 Street and Road Improvement Funds, and shall include a budget, scope, and schedule, as
19 well as any other information requested by the Board. The Plan should also address the
20 relative need or urgency, cost effectiveness, and fair geographic distribution of resources,
21 taking into account the various needs of San Francisco's neighborhoods. The Plan shall be
22 coordinated with other relevant City agencies including the Planning Department and the
23 Municipal Transportation Agency, as well as the San Francisco Transportation Authority. The
24 Plan should identify attempts to leverage or match Proposition 1B Local Street and Road
25 Improvement Funds with funding from other sources, including any other state or federal

1 funds. No City Department shall expend or encumber any Proposition 1B Local Street and
2 Road Improvement Funds without approval from the Board of Supervisors pursuant to this
3 ordinance. Any Proposition 1B Local Street and Road Improvement Funds received by the
4 City and County of San Francisco will be deposited into a local account named "The
5 Proposition 1B Local Account," and shall remain in such account until the Board of
6 Supervisors approves a department's specific spending plan. Under no circumstances will
7 Proposition 1B Local Street and Road Improvement Funds be mixed with other funds prior to
8 the approval of the spending plans as outlined in this paragraph. Proposition 1B Local Street
9 and Road Improvement Funds can be appropriated as part of the annual budget process only
10 if the requirements of this paragraph are met. The Board of Supervisors further encourages
11 any department seeking such an appropriation to consult and work with its commission if any,
12 the public, and the Board on the development of such spending plans.

13 (4) Any department that receives an appropriation of Proposition 1B Local
14 Street and Road Improvement Funds shall report back to the Board of Supervisors beginning
15 six months from the date of the appropriation, and at six-month intervals thereafter until the
16 appropriation has been spent. The report required by this Section shall state the amount of
17 Proposition 1B Local Street and Road Improvement Funds expended as of the reporting date
18 and shall describe the progress on the project, the projected date of completion, and such
19 additional information as the Board may require as a condition of the appropriation.


20 (5) The Controller shall perform an audit every two years of all Proposition 1B
21 Local Street and Road Improvement Funds that are allocated, whether expended or not, to
22 determine what projects were actually funded. Any Department receiving Proposition 1B
23 Local Street and Road Improvement Funds shall cooperate with the Controller's Office in the
24 performance of the audit.
25

1 Section 2. Effective Date. This ordinance shall become effective 30 days from the
2 date of passage.

3
4 Section 3. This section is uncodified. In enacting this Ordinance, the Board intends to
5 amend only those words, phrases, paragraphs, subsections, sections, articles, numbers,
6 punctuation, charts, diagrams, or any other constituent part of the Administrative Code that
7 are explicitly shown in this legislation as additions, deletions, Board amendment additions,
8 and Board amendment deletions in accordance with the "Note" that appears under the official
9 title of the legislation.

LEGISLATIVE DIGEST
(Substitute Legislation, dated 3/13/2012)

[Administrative Code – Board Approval of Grants Over \$100,000]

Ordinance amending the San Francisco Administrative Code by amending Section 10.170 1, to set a threshold of \$100,000 or more for Board of Supervisors approval of the acceptance and expenditure of grants.

Existing Law

Before a City department may accept and expend a state, federal, or other grant, the Board of Supervisors must approve the action by resolution.

Amendments to Current Law

The proposal would amend the Administrative Code to provide that Board approval would only be required for grants of \$100,000 or more (including any required City matching funds), and would authorize the Controller to adopt rules as necessary for the acceptance and expenditure of grants in amounts less than \$100,000.

A grant that included the creation of a position in City service would still have to be approved by ordinance of the Board of Supervisors, regardless of the amount of the grant.

This substitute legislation, dated 3/13/2012, differs from the legislation on file, dated 2/28/2012, in one respect. In proposed Section 10.170-1(b), the substitute ordinance adds (at page 1, lines 19-20 of the draft) the following language: "If as a condition of the grant, the City is required to provide any matching funds, those funds shall be included in determining whether the grant meets the \$100,000 threshold."
