

1 [Accept and Expend Grant - Veterans Administration Specialty Care Access Networks  
2 Extension for Community Healthcare Outcomes Project - \$16,447]

3 **Resolution authorizing the Department of Public Health to retroactively accept and**  
4 **expend a grant in the amount of \$16,447 from the San Francisco Department of**  
5 **Veterans Affairs Medical Center, to participate in a program entitled Veterans**  
6 **Administration Specialty Care Access Networks Extension for Community Healthcare**  
7 **Outcomes Project for the period of March 1, 2012, through September 30, 2012.**

9 WHEREAS, San Francisco Department of Veterans Affairs Medical Center has agreed  
10 to fund Department of Public Health (DPH) in the amount of \$16,447 for the period of March  
11 1, 2012, through September 30, 2012; and

12 WHEREAS, As a condition of receiving the grant funds, San Francisco Department of  
13 Veterans Affairs Medical Center requires the City to enter into an agreement (Agreement), a  
14 copy of which is on file with the Clerk of the Board of Supervisors in File No. 120445; which is  
15 hereby declared to be a part of this Resolution as if set forth fully herein; and

16 WHEREAS, The purpose of this project is to perform HIV infectious disease trainings in  
17 support of the Veterans Administration Specialty Care Access Networks Extension for  
18 Community Healthcare Outcomes Project in San Francisco; and

19 WHEREAS, An ASO amendment is not required as the grant partially supports one  
20 existing position, one Senior Physician Specialist (Job Class No. 2232) at 1.0 FTE, for the  
21 period of March 1, 2012, through September 30, 2012; and

22 WHEREAS, A request for retroactive approval is being sought because DPH did not  
23 receive notification of the award until March 13, 2012, for a project start date of March 1,  
24 2012; and

1           WHEREAS, The budget includes a provision for indirect costs in the amount of \$3,415;  
2 now, therefore, be it

3           RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant  
4 in the amount of \$16,447 from the San Francisco Department of Veterans Affairs Medical  
5 Center; and, be it

6           FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and  
7 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,  
8 be it

9           FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
10 Agreement on behalf of the City.
