
- 1. Sales of alcoholic beverages shall only be between the hours of 7:00 AM and 9:00PM, daily.
- 2. The sale of distilled spirits in sizes smaller than 375 ml is strictly prohibited.

- 3. No malt beverages shall be sold with an alcoholic content greater than 5.7% by volume.
- 4. There shall be no plastic cups, disposable glasses, or similar disposable receptacles commonly used for the drinking of beverages, sold, furnished, or given away at the petitioner's premises in quantities of less than twenty-four (24) in their original multi-container package.
- 5. All ice shall be sold at or above prevailing prices in the area and in quantities of not less than three (3) pounds per sale and shall not be given away free.
- 6. Wine shall not be sold in bottles or containers smaller than 750 ml.
- 7. Wine-coolers, beer coolers, or pre-mixed distilled spirit cocktails must be sold in manufacturer pre-packaged multi-unit quantities.




