17 Be it ordained by the People of the City and County of San Francisco:

18 Section 1. On February 1, 2012, pursuant to Board of Supervisors Resolution 11-12
19 [Transfer of Assets, Obligations, and Functions to the City as Successor Agency for the
20 Redevelopment Agency As Required By State Law] the City and County of San Francisco
21 ("City") became the successor agency to the Redevelopment Agency of the City and County
22 of San Francisco ("Successor Agency"). The Board of Supervisors hereby adopts and
23 implements, on behalf of the City as the Successor Agency, Amendment #2 amending the
24 2009-2011 Memorandum of Agreement between the Redevelopment Agency of the City and
25 County of San Francisco and International Federation of Professional and Technical

1 Engineers, Local 21, AFL-CIO (Engineers and Architects Unit) by extending the term of the
2 Agreement through June 30, 2012, and by implementing specified terms and conditions of
3 employment for 2011-2012.
