1 [Appropriating \$587,756,000 for Wastewater Capital Improvements at the Public Utilities Commission for FY2012-2013 and FY2013-2014]

Ordinance appropriating \$587,756,000 of proceeds from revenue bonds, wastewater revenue, state grants and bond interest income for the San Francisco Public Utilities Commission (SFPUC) Wastewater Enterprise's Capital Improvement Program, comprised of \$299,402,000 for Fiscal Year 2012-2013, and \$288,354,000 for Fiscal Year 2013-2014, and placing \$255,600,000 on Board Finance Committee reserve as well as placing all applicable appropriations by project on Controller's reserve subject to SFPUC's and Board of Supervisors' discretionary approval following completion of project-related analysis pursuant to the California Environmental Quality Act (CEQA), where required, and receipt of proceeds of indebtedness, accept and expend a Department of Water Resources administered grant in the amount of \$24,147,000 and allow reimbursement of prior expenditures, funded from Wastewater Revenue Bonds, to be funded by the grant retroactive to December, 2011. If the State delays the disbursement of the \$24,147,000 in grant funding, Wastewater revenue bonds may be substituted as a source for the grant funds.

Section 4. Of the above appropriated amount, \$1,046,954, representing 0.2% of the expenditure budget net of bond financing and audit costs is to be allocated and available to support the Controller's Audit Fund, pursuant to Charter Appendix F1.113; and \$246,405, representing 0.05% of gross bond proceeds is to be allocated and available to support the Public Utilities Commission Revenue Bond Oversight Committee, pursuant to Administrative Code Section 5A.31. These appropriations may be increased or decreased by the Controller based on changes to expenditure appropriations or actual gross bond proceeds to conform to the applicable Charter and Administrative Code formulas.

Section 5. Of the above appropriated amount, \$62,985,641 is appropriated for bond financing costs, including but not limited to, issuance costs, debt service reserve, capitalized interest, rating agency, and disclosure costs, all on controllers reserve pending receipt of bond proceeds. To the extent that net available bond proceeds after financing costs are more than budgeted, the Department may use such surplus bond proceeds as a substitute for other sources budgeted in this appropriation.

Section 6. The appropriations herein are effective as of July 1, 2012. The bond-funded portion of all included appropriation shall be placed on Controller's Reserve pending the availability of funds. The portion of appropriation funded by FY 2013-14 local operating revenues shall be placed on Controller's Reserve until July 1, 2013. Release of project-related appropriation reserves by the Controller is also subject to the prior occurrence of the SFPUC's and the Board of Supervisors' discretionary adoption of CEQA findings for projects, following review and consideration of completed project-related environmental analysis, where required, pursuant to CEQA, the State CEQA Guidelines, and Chapter 31 of the San Francisco Administrative Code.

Section 7. The appropriations herein of \$255,600,000 related to the planned FY 2013-14 wastewater capital improvements are placed on Board Finance Committee reserve pending further review of Sewer System Improvement Program timing, sizing and scoping updates.

Section 78. The Controller is authorized to record transfers between funds and adjust the accounting treatment of sources and uses appropriated in this ordinance as necessary to conform to Generally Accepted Accounting Principles.
