Laura Guzman (residency requirement waived,) seat 1, succeeding herself, term expired, must be a member of the disabled community, for the unexpired portion of a four-year term ending October 21, 2015.

FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 1. The membership of the Local Homeless Coordinating Board has a goal to be representative of the diversity of the City and County of San Francisco.
- Applicant Laura Guzman, who is not a resident of San Francisco, is a person with experience that uniquely qualifies her to serve on the Local Homeless Coordinating Board.
- 3. The Local Homeless Coordinating Board has attempted to fill the position, for which Laura Guzman was nominated, with an individual who is a City resident and who has the specific experience, skills, and qualifications, but has been unable to do so at this time. The Rules Committee has certified that Laura Guzman is qualified to serve on the Local Homeless Coordinating Board.

specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Local Homeless Coordinating Board at this time; and, be it FURTHER MOVED, That the Board of Supervisors waives the residency requirement for Laura Guzman, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
