WHEREAS, The State and Presidio Trust have executed a Freeway Maintenance
Agreement Document File No. SF-38-015936 to clarify the division of maintenance
responsibility for such improvements constructed pursuant to said Cooperative Agreement. A
copy of said Agreement is on file with the Clerk of the Board of Supervisors in File No. 120070
and is incorporated herein by reference; and

WHEREAS, The State and the Department of Public Works, acting on behalf of the City and County of San Francisco, mutually desire to clarify the division of maintenance responsibility for such improvements constructed pursuant to said Cooperative Agreement as to City streets or portions thereof and improvements and landscaped areas within or outside the freeway limits; and

WHEREAS, The State and City staff have negotiated a Freeway Maintenance

Agreement, a copy of which is on file with the Clerk of the Board of Supervisors in File No.

120070 and is incorporated herein by reference. Said Agreement establishes maintenance responsibility for the above-mentioned Presidio Trust Improvements; and

WHEREAS, The Department of Public Works and other affected City departments will be entering into an interdepartmental Memorandum of Understanding that delineates the responsibilities of each department in regard to the City maintained improvements; and

WHEREAS, The City has resumed or will resume control and maintenance over each of the relocated or reconstructed City streets except on those portions thereof identified in the Agreement; and

WHEREAS, The Agreement, except as specifically provided for herein, does not effect the terms of prior written agreements, which include, but are not limited to, various agreements for maintenance of State Highways in the City and County of San Francisco; and

WHEREAS, The Board accepts the recommendations set forth in DPW Order No. 180,020 concerning said Agreement. A copy of the DPW Order is on file with the Clerk of the Board of Supervisors in File No. 120070 and is incorporated herein by reference; now, therefore, be it

RESOLVED, That the Board of Supervisors approves the Freeway Maintenance

Agreement for Highway 101/Richardson Avenue at Lyon Street and authorizes the Director of

Public Works to execute the Agreement with the State; and, be it

FURTHER RESOLVED, That the Board of Supervisors authorizes the City to assume the maintenance responsibilities over the particular Presidio Trust Improvements that are mentioned in the Freeway Maintenance Agreement (under section 2(B)); and, be it

FURTHER RESOLVED, That the Board of Supervisors delegates to the DPW Director the authority to administratively approve minor amendments to the Freeway Maintenance Agreement (as contemplated under Section 2(E)); and, be it

FURTHER RESOLVED, That the Board of Supervisors delegates to the DPW Director, with the consent of the General Manager of the San Francisco Municipal Transportation Agency, that authority to assume maintenance of the traffic devices if State delegates this responsibility to the City (under Section 3(B)); and, be it

FURTHER RESOLVED, That the Board hereby directs the Clerk to send four (4) certified copies of this Resolution to the State at an address to be provided by the Director of the Department of Public Works.
