

1 [Preservation and Display of First Responder Artifacts and Facilities by Guardians of the City]

3 **Resolution urging the San Francisco Fire Department (SFFD), Police Department**  
4 **(SFPD), Sherriff, and Department of Emergency Management (DEM), in consultation**  
5 **with the City Attorney's Office, the Purchaser, the Department of Real Estate, and any**  
6 **other agencies with jurisdiction over former Fire, Police, or Sherriff's Department**  
7 **artifacts and facilities, to consider (1) preparing an agreement for possible loan of**  
8 **historical artifacts and surplus property from SFFD, SFPD, Sherriff, and DEM ("First**  
9 **Responder Artifacts") to a nonprofit 501(c)(3) organization known as Guardians of the**  
10 **City (GOTC) for management, research, care, conservation, and public display, (2)**  
11 **entering into a lease or other agreements regarding GOTC's use of space in SFFD or**  
12 **other City facilities for GOTC's public exhibitions and related administrative activities,**  
13 **and possible preservation of historic facilities, and (3) development of other methods**  
14 **of supporting and encouraging the collection, preservation, protection, and public**  
15 **display of important First Responder Artifacts and facilities for the benefit of current**  
16 **and future generations.**

18 WHEREAS, The City's Fire, Police, Sherriff, and Emergency Management  
19 Departments (the "First Responder Departments") play a critical role in the safety of the City,  
20 its residents and visitors; and

21 WHEREAS, The First Responder Departments have irreplaceable historical documents  
22 and artifacts that reflect the history of those departments as well as the City; and

23 WHEREAS, Many San Francisco residents and other private individuals have  
24 expressed an interest in donating important privately-owned historical artifacts related to first  
25 responders; and

1           WHEREAS, The City has a strong interest in encouraging the stewardship and  
2 conservation of such artifacts in order to celebrate the heritage and history of the City and  
3 County of San Francisco and its First Responder Departments and to recognize the important  
4 contributions of the individuals who have dedicated their lives to public safety in San  
5 Francisco; and

6           WHEREAS, The City's procedures for the removal of surplus property from the First  
7 Responder Departments and other agencies holding First Responder Artifacts could be  
8 improved to help better safeguard surplus property that has historical, scientific, aesthetic, or  
9 cultural value; and

10           WHEREAS, The Guardians of the City (GOTC) is a new 501(c)(3) nonprofit  
11 organization formed by current and former members of the First Responder Departments  
12 whose primary purpose is to provide stewardship and conservation of a collection of  
13 irreplaceable artifacts that celebrate the heritage and history of the City's First Responder  
14 Departments; and

15           WHEREAS, The GOTC plans memorial walls and gardens to honor the first  
16 responders who fell in the line of duty as well as exhibitions of First Responder historical  
17 artifacts; and

18           WHEREAS, The GOTC plans to curate exhibitions of First Responder photographs,  
19 documents, signs, memorabilia, journals, historical uniforms, badges, helmets, equipment,  
20 and apparatus at community events, parades, museum facilities, and other City facilities and  
21 public venues; and

22           WHEREAS, The GOTC is working in consultation with museum experts to help  
23 research and catalogue First Responder Artifacts for the public benefit; and

24           WHEREAS, A formal agreement and possible lease with the GOTC could serve the  
25 public interest by further confirming the City's support of GOTC's mission and ensuring

1 greater understanding and access to First Responder Artifacts and the rich history that they  
2 represent; now, therefore, be it

3           RESOLVED, That the Board of Supervisors hereby urges the San Francisco  
4 Fire Department (SFFD), Police Department (SFPD), Sherriff, and Department of Emergency  
5 Management (DEM), in consultation with the City Attorney's Office, the Purchaser, the  
6 Department of Real Estate, and any other agencies with jurisdiction over former Fire, Police,  
7 or Sherriff's Department artifacts and facilities, to consider (1) preparing an agreement for  
8 possible loan of historical artifacts and surplus property from SFFD, SFPD, Sherriff, and DEM  
9 ("First Responder Artifacts") to a nonprofit 501(c)(3) organization known as Guardians of the  
10 City (GOTC) for management, research, care, conservation, and public display, (2) entering  
11 into a lease or other agreements regarding GOTC's use of space in SFFD or other City  
12 facilities for GOTC's public exhibitions and related administrative activities, and possible  
13 preservation of historic facilities, and (3) development of other methods of supporting and  
14 encouraging the collection, preservation, protection, and public display of important First  
15 Responder Artifacts and facilities for the benefit of current and future generations.
