

1 [Accept and Expend Grant - Addressing Syndemics through Program Collaboration and
2 Service Integration - \$298,144]

3 **Resolution authorizing the San Francisco Department of Public Health to retroactively**
4 **accept and expend a grant in the amount of \$298,144 from Public Health Foundation**
5 **Enterprises, Inc., to participate in a program entitled “Addressing Syndemics through**
6 **Program Collaboration and Service Integration” for the period of September 30, 2011,**
7 **through September 29, 2012.**

9 WHEREAS, Public Health Foundation Enterprises, Inc. (PHFE) is the recipient of a
10 grant award from Centers for Disease Control and Prevention supporting the Addressing
11 Syndemics through Program Collaboration and Service Integration grant; and

12 WHEREAS, With a portion of these funds, PHFE has subcontracted with Department
13 of Public Health (DPH) in the amount of \$298,144 for the period of September 30, 2011,
14 through September 29, 2012; and

15 WHEREAS, As a condition of receiving the grant funds, PHFE requires the City to
16 enter into an agreement (Agreement), a copy of which is on file with the Clerk of the Board of
17 Supervisors in File No. _____; which is hereby declared to be a part of this
18 Resolution as if set forth fully herein; and

19 WHEREAS, The purpose of this project is to develop and maintain relational databases
20 for Program Collaboration and Service Integration (PCSI); and

21 WHEREAS, An Annual Salary Ordinance amendment is not required as the grant
22 partially reimburses DPH for two existing positions, one Epidemiologist II (Job Class No.
23 2803) at .50 FTE and one Health Program Planner (Job Class No. 2818) at 1.00 FTE for the
24 period of September 30, 2011, through September 29, 2012; and

1 WHEREAS, A request for retroactive approval is being sought because DPH did not
2 receive notification of the agreement until May 17, 2012, for a project start date of September
3 30, 2011; and

4 WHEREAS, The budget includes a provision for indirect costs in the amount of
5 \$31,869; now, therefore, be it

6 RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant
7 in the amount of \$298,144 from PHFE; and, be it

8 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
9 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,
10 be it

11 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
12 Agreement on behalf of the City.
