14	Be it ordained by the People of the City and County of San Francisco:
15	
16	Section 1. The Planning Department has determined that the actions contemplated in
17	this Ordinance comply with the California Environmental Quality Act (California Public
18	Resources Code Section 21000 et seq.). Said determination is on file with the Clerk of the
19	Board of Supervisors in File No and is incorporated herein by reference.
20	
21	Section 2. Pursuant to Article XIIIC of the Constitution of the State of California, this
22	Ordinance shall be submitted to the qualified electors of the City and County of
23	San Francisco, at the November 6, 2012 consolidated general election.

1	Section 3. The San Francisco Business and Tax Regulations Code is hereby amended
2	by adding Article 12-A-1 to read as follows:
3	
4	SEC. 950. FINDINGS AND PURPOSE.
5	The voters hereby find and declare as follows:
6	1. San Francisco is the only major city in California that levies its entire business tax on
7	payroll expense. This exclusive payroll-based tax discourages job creation and economic growth,
8	lowers wages, and provides an unstable revenue stream.
9	2. San Francisco currently charges a flat rate on its payroll expense tax base. Instituting a
10	tiered rate structure, in which businesses are taxed based on their gross receipts, will better distribute
11	the tax burden according to a business's ability to pay.
12	3. Gross receipts is the most common business tax base among California's largest cities.
13	4. Amending San Francisco's business tax system to include a gross receipts tax will promote
14	revenue stability by diversifying the tax base.
15	5. The rate schedules and the small business exemption for businesses with receipts under
16	<u>\$1,000,000 provide particular tax relief to small businesses.</u>
17	6. The legislation will gradually phase in the new gross receipts tax over a five-year period,
18	beginning in tax year 2014, to allow businesses time to adjust to the change and to minimize the risk to
19	the City and to taxpayers of instability in City revenues during the transition from the payroll expense
20	tax to a gross receipts tax.
21	7. Also beginning in tax year 2014, the payroll expense tax will be adjusted, over the same
22	period, in increments that are consistent with the phase in of the gross receipts tax.
23	8. Each year during the phase-in period, the formula dictates an increase in the gross receipts
24	tax rate and an adjustment in the payroll expense tax rate that is expected to reduce the payroll expense
25	tax rate to zero by or before 2018. The Controller will calculate the annual increase in the gross

5	This Article shall be known as the "Gross Receipts Tax Ordinance" and the tax this Article
6	imposes shall be known as the "Gross Receipts Tax."

8	SEC. 952. DEFINITIONS.
9	Except where the context otherwise requires, the terms used in this Article shall have the
10	meanings given to them in Sections 6.2-1 et seq. of Article 6 and in Article 12-A.

13	"Advance payment" means a nonrefundable payment for the purchase of property or services to

17	"Cash discount" means a deduction from the invoice price of goods or charge for services
18	which is allowed if the bill is paid on or before a specified date, or paid in cash rather than by credit
19	<u>card.</u>

21	<u>SEC. 952.3. GROSS RECEIPTS.</u>
22	(a) "Gross receipts" means the total amounts received or accrued by a person from whatever
23	source derived, including, but not limited to, amounts derived from sales, services, dealings in
24	property, interest, rent, royalties, dividends, licensing fees, other fees, commissions and distributed
25	amounts from other business entities. Except as otherwise specifically provided in this Article, gross

2	purposes. Gross receipts includes all receipts, cash, credits and property of any kind or nature and
3	including any amount for which credit is allowed by the seller to the purchaser, without any deduction
4	therefrom on account of the cost of the property sold, the cost of materials used, labor or service costs,
5	interest paid or payable, losses or any other expense whatsoever, except that cash discounts allowed or
6	taken on sales shall not be included as gross receipts. Gross receipts, including advance payments,
7	shall be included in a taxpayer's gross receipts at the time such receipts are recognized as revenue for
8	federal income tax reporting purposes.
9	(b) "Gross receipts" with respect to any lease or rental shall include payment for any services
10	that are part of the lease or rental, whether received in money or otherwise, that are paid to, on behalf
11	of, or for the benefit of, the lessor, and all receipts, cash, credits, property of any kind or character and
12	the fair market value of services so paid or rendered by the lessee.
13	(c) Treatment of Taxes. "Gross receipts" shall not include the amount of any federal, state, or
14	local tax imposed on or with respect to retail sales whether imposed upon the retailer or upon the
15	purchaser and regardless of whether the amount of tax is stated as a separate charge, or such part of
16	the sales price of any property previously sold and returned by the purchaser to the seller which is
17	refunded by the seller by way of cash or credit allowances given or taken as part payment on any
18	property so accepted for resale. Gross receipts shall also not include any federal, state or local tax
19	imposed upon a person for which that person is reimbursed by means of a separately stated charge to a
20	purchaser, lessee, licensee or customer. Gross receipts shall not include any amount of third-party
21	taxes that a taxpayer collects from or on behalf of the taxpayer's customers and remits to the
22	appropriate governmental entity imposing such tax. Gross receipts shall not include any tax refunds
23	received by a person from a governmental entity. Gross receipts shall include any federal, state or
24	local tax not specifically excluded in this subsection.

1	(d) "Gross receipts" shall not include any amount received from or charged to any person that
2	is a related entity to the taxpayer. Nor shall gross receipts include any grants received from
3	governmental entities or any gifts. Gross receipts also shall not include any distributions (such as
4	dividends, interest and other returns on capital) from an entity treated as a pass-through entity for
5	federal income tax purposes, provided such distributions are derived exclusively from an investment in
6	such entity, and that such entity is a person or a member of a combined group subject to the gross
7	<u>receipts tax.</u>
8	(e) "Gross receipts" from the sale or exchange of stocks or other similar written instruments
9	evidencing a right to participate in the assets of any business, or of bonds or other evidence of
10	indebtedness, or of any other marketable securities (collectively referred to in this Article as "financial
11	instruments") or of any real property shall not include the cost to acquire the financial instrument(s),
12	or real property sold or otherwise exchanged or converted. To the extent that any loss on the sale or
13	exchange of financial instruments reduces the gross income of a person for federal income tax purposes
14	in the year the loss is incurred, that loss shall reduce gross receipts from the sale or exchange of
15	financial instruments, but in no event shall those receipts be less than zero, and in no event may any
16	such loss be carried back or carried forward to reduce gross receipts in a tax year other than that in
17	which the loss was incurred.
18	(f) No person shall be deemed to be engaging in business in the City if that person is an
19	individual whose only gross receipts within the City are derived from investments of that individual's
20	own funds in financial instruments. Gross receipts of an individual shall not include interest,
21	dividends, capital gains and similar items or investment income earned from the investment of that
22	individual's own capital.
23	(g) For purposes of this Article and Article 12, and notwithstanding Section 6.2-12 of Article 6,
24	no person shall be deemed to be engaging in business within the City if its activities in the City consist
25	solely of one or more of the following:

2	"Sale" and "sell" mean the making of any transfer of title, in any manner or by any means
3	whatsoever, to property for a price, and to the serving, supplying or furnishing, for a price, of any
4	property fabricated or made at the special order of consumers who do or who do not furnish directly or
5	indirectly the specifications or materials therefor. A transaction whereby the possession of property is
6	transferred but the seller retains the title as a security for the payment of the price shall likewise be

9	SEC. 953. IMPOSITION OF GROSS RECEIPTS TAX.
10	(a) Except as otherwise provided under this Article, the City imposes and every person
11	engaging in business within the City shall pay an annual gross receipts tax measured by the person's
12	gross receipts from all taxable business activities attributable to the City. A person's liability for the
13	gross receipts tax shall be calculated according to Sections 953.1 through 953.7.
14	(b) The gross receipts tax is a privilege tax imposed upon persons engaging in business within
15	the City for the privilege of engaging in a business or occupation in the City. The gross receipts tax is
16	imposed for general governmental purposes. Proceeds from the tax shall be deposited in the City's
17	general fund and may be expended for any purposes of the City.
18	(c) The voters intend by adopting this measure to authorize application of the gross receipts tax
19	in the broadest manner consistent with the provisions of this Article and the requirements of the
20	California Constitution, the United States Constitution, and any other applicable provision of federal
21	and state law.
22	(d) The gross receipts tax imposed under this Article is in addition to the payroll expense tax
23	imposed under Article 12-A. Persons not otherwise exempt from the gross receipts tax or payroll
24	expense tax shall pay both taxes. Persons exempt from either the gross receipts tax or payroll expense
25	tax, but not both, shall pay the tax from which they are not exempt.

13	<u>0.150% (e.g., \$1.50 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000</u>
14	<u>0.175% (e.g., \$1.75 per \$1,000) for gross receipts over \$25,000,000</u>
15	(b) Retail trade includes the activity of retailing any type of personal property, generally
16	without significantly transforming its characteristics, and rendering services incidental to the retail
17	sale of property; it includes business activity described in NAICS codes 44 and 45.
18	(c) Wholesale trade includes the activity of wholesaling property, generally without
19	transformation, and rendering services incidental to the sale of property on a wholesale basis; it
20	includes business activity described in NAICS code 42.
21	(d) Certain services includes the repair and maintenance services, personal and laundry
22	services, and religious, grantmaking, civic, professional and similar organizations that are not
23	otherwise exempt; it includes business activity described in NAICS codes 811, 812 and 813.
24	
25	

1	(e) The amount of gross receipts from retail trade activities and from wholesale trade activities
2	subject to the gross receipts tax shall be one-half of the amount determined under Section 956.1 plus
3	one-half of the amount determined under Section 956.2.
4	(f) The amount of gross receipts from certain services activities subject to the gross receipts tax
5	shall be the total amount determined under Section 956.2.
6	
7	SEC. 953.2. GROSS RECEIPTS TAX APPLICABLE TO MANUFACTURING;
8	TRANSPORTATION AND WAREHOUSING; INFORMATION; BIOTECHNOLOGY; CLEAN
9	TECHNOLOGY; AND FOOD SERVICES.
10	(a) The base gross receipts tax rate provided by this Section is applicable to the business
11	activities of manufacturing, transportation and warehousing, information, biotechnology, clean
12	technology, and food services. Commencing on the operative date of the Gross Receipts Tax
13	Ordinance, the Controller shall compute the tax rate in accordance with Section 959, but the base tax
14	rate provided by this Section is:
15	0.125% (e.g., \$1.25 per \$1,000) for gross receipts between \$0 and \$1,000,000

17	0.350% (e.g., \$3.50 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000

19	(b) Manufacturing includes the activity of transforming materials, substances or components
20	into new products by mechanical, physical or chemical means; it includes the activity of assembling
21	component parts of manufactured products; it includes business activity described in NAICS codes 31,
22	<u>32 and 33.</u>
23	(c) Transportation and warehousing includes the activities of providing transportation of
24	passengers and/or goods, warehousing and storage for goods, scenic and sightseeing transportation,

1	and support activities related to modes of transportation; it includes business activity described in
2	NAICS codes 48 and 49.
3	(d) Information includes producing and distributing information or cultural products;
4	providing the means to transmit or distribute those products; and processing data; it includes business
5	activity described in NAICS code 51.
6	(e) For purposes of this Article, biotechnology includes the activity of biotechnology business
7	as defined in Section 906.1 of Article 12-A, and clean technology includes the activity of clean
8	technology business as defined in Section 906.2 of Article 12-A.
9	(f) Food services includes the activity of preparing meals, snacks and/or beverages to customer
10	order for immediate on-premises or off-premises consumption; it includes drinking places; it includes
11	business activity described in NAICS code 722.
12	(g) The amount of gross receipts from all business activities described in this Section subject to
13	the gross receipts tax shall be one-half of the amount determined under Section 956.1 plus one-half of
14	the amount determined under Section 956.2.
15	
16	SEC. 953.3. GROSS RECEIPTS TAX APPLICABLE TO ACCOMMODATIONS; UTILITIES;
17	AND ARTS, ENTERTAINMENT AND RECREATION.
18	(a) The base gross receipts tax rate provided by this Section is applicable to each of the
19	following business activities: accommodations; utilities; and arts, entertainment and recreation.
20	Commencing on the operative date of the Gross Receipts Tax Ordinance, the Controller shall compute
21	the tax rate in accordance with Section 959, but the base tax rate provided by this Section is:
22	0.300% (e.g., \$3 per \$1,000) for gross receipts between \$0 and \$1,000,000
23	0.350% (e.g., \$3.50 per \$1,000) for gross receipts between \$1,000,001 and \$2,500,000
24	<u>0.375% (e.g., \$3.75 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000</u>
25	<u>0.400% (e.g., \$4 per \$1,000) for gross receipts over \$25,000,000</u>

1	(b) Accommodations includes the activity of providing lodging or short-term accommodations
2	for travelers, vacationers, or others; it includes business activity described in NAICS code 721.
3	(c) Utilities includes the activities of the generation, transmission and distribution of electric
4	power, the distribution of natural gas, the provision and distribution of steam supply, the treatment and
5	distribution of water supply, and the removal of sewage; it includes business activity described in
6	NAICS code 22; it excludes establishments primarily engaged in waste management services.
7	(d) Arts, entertainment and recreation include the activity of operating facilities or providing
8	services to meet cultural, entertainment or recreational interests of customers or patrons; it includes
9	business activity described in NAICS code 71.
10	(e) The amount of gross receipts and from accommodations subject to the gross receipts tax
11	shall be the total amount of gross receipts derived from or related to properties located or used within
12	the City.
13	(f) The amount of gross receipts from utilities subject to the gross receipts tax shall be one-half
14	of the amount determined under Section 956.1 plus one-half of the amount determined under

16	(g) The amount of gross receipts from arts, entertainment and recreation subject to the gross
17	receipts tax shall be the total amount determined under Section 956.2.

19	SEC. 953.4. GROSS RECEIPTS TAX APPLICABLE TO PRIVATE EDUCATION AND HEALTH
20	SERVICES; ADMINISTRATIVE AND SUPPORT SERVICES; AND MISCELLANEOUS
21	BUSINESS ACTIVITIES.
22	(a) The base gross receipts tax rate provided by this Section is applicable to the business
23	activities of private education and health services, and administrative and support services. This rate

11	activities for the day-to-day business activities of others; it includes business activity described in
12	<u>NAICS code 56.</u>
13	(d) The amount of gross receipts from all business activities described in this Section subject to
14	the gross receipts tax shall be determined under Section 956.2.
15	
16	SEC. 953.5. GROSS RECEIPTS TAX APPLICABLE TO CONSTRUCTION.
17	(a) The base gross receipts tax rate provided by this Section is applicable to the business
18	activity of construction. Commencing on the operative date of the Gross Receipts Tax Ordinance, the
19	Controller shall compute the tax rate in accordance with Section 959, but the base tax rate provided by
20	this Section is:
21	<u>0.300% (e.g., \$3 per \$1,000) for gross receipts between \$0 and \$1,000,000</u>

The Hotel Tax (Article 7) and the Parking Tax (Article 9) shall be remitted monthly. Such monthly remittances shall be due and payable to 14 the Tax Collector on or before the last day of the month immediately following the month for 15 which such remittance is due. Taxes paid in the first 2 monthly remittances of any quarterly 16 17 period shall be a credit against the total liability for such third-party taxes for the quarterly 18 period. The third monthly remittance of any guarterly period shall be in an amount equal to the total tax liability for the quarterly period, less the amount of any monthly remittance for such 19 20 quarter actually paid. (2) Payroll Expense Tax and Gross Receipts Tax. The Ppayroll Eexpense Ttax 21 (Article 12-A) and the gross receipts tax (Article 12-A-1) shall be paid in biannual or quarterly 22 23 installments as follows: 24 (A) Small Firm Prepayments. 6 (b) Tax Prepayment Penalties. Every person who fails to pay any tax prepayment 7 required under this Section before the relevant delinquency date shall pay a penalty in the 8 amount of 5 percent of the amount of the delinquent tax prepayment per month, or fraction 9 thereof, up to 20 percent in the aggregate, and shall also pay interest on the amount of the 10 delinquent tax prepayment and penalties from the date of delinquency at the rate of 1 percent 11 per month, or fraction thereof, for each month the prepayment is delinquent, until paid.

(c) Hotel and Parking Taxes. An operator subject to the Hotel Tax (Article 7) or the
 Parking Tax (Article 9) shall make monthly remittances in the amount of the actual tax owed.

(d) Forms and Adjustments. Tax prepayments required under this Section shall be 14 accompanied by a tax prepayment form prepared by the Tax Collector, but failure of the Tax 15 Collector to furnish the taxpayer with a tax prepayment form shall not relieve the taxpayer 16 17 from any tax prepayment obligation. The Tax Collector may, in writing, adjust the amount of a 18 tax prepayment if the taxpayer can establish in writing by clear and convincing evidence that the first installment of semi-annual tax prepayments, or first, second or third monthly 19 20 installment of a quarterly tax prepayment, will amount to more than one-half or one-quarter, 21 respectively, of the person's total tax liability for the tax year in which the installment is due.

### 23 <u>SEC. 6.24-1. AMENDMENT OF ORDINANCE.</u>

- 24 <u>The Board of Supervisors may amend or repeal Article 6 of the Business and Tax Regulations</u>
- 25 <u>Code without a vote of the people except as limited by Article XIIIC of the California Constitution.</u>

1 Section 8. Effective Date.

2 This measure shall go into effect 10 days after the date the official vote count is3 declared by the Board of Supervisors.

Section 9. Severability.

6 Except as provided in Section 11 of this Ordinance, if any section, sentence, clause, 7 phrase, or portion of this Ordinance is for any reason held to be invalid or unenforceable by a 8 court of competent jurisdiction, the remaining sections, sentences, clauses, phrases, or 9 portions of this Ordinance shall nonetheless remain in full force and effect. The people of the City and County of San Francisco hereby declare that, except as provided in Section 11, they 10 would have adopted each section, sentence, clause, phrase, or portion of this Ordinance, 11 12 irrespective of the fact that any one or more sections, sentences, clauses, phrases, or 13 portions of this Ordinance be declared invalid or unenforceable and, to that end, the 14 provisions of this Ordinance are severable.

16 Section 10. Savings Clause.

17 (a) No section, clause, part or provision of this Ordinance shall be construed as 18 requiring the payment of any tax that would be in violation of the Constitution or laws of the United States or of the Constitution or laws of the State of California. Except as provided in 19 20 Section 965(b) of Article 12-A-1 of this Ordinance, if any section, clause, part or provision of this Ordinance, or the application thereof to any person or circumstances, is held invalid or 21 unconstitutional, the remainder of this Ordinance, including the application of such part or 22 23 provision to other persons or circumstances, shall not be affected thereby and shall continue in full force and effect. To this end, the provisions of this Ordinance are severable. 24

1	(b) If the imposition of the gross receipts tax in Section 953 of Article 12-A-1 of this
