3 **Ordinance authorizing the settlement of a lawsuit filed by Maura Moylan and Anne**  
4 **Raskin against the City and County of San Francisco, Janice Madsen, Kym Dougherty**  
5 **and Heather Grives for \$762,000.00; the lawsuit was filed on October 14, 2010, in United**  
6 **States District Court for the Northern District of California, Case No. C10-04700, entitled**  
7 **Maura Moylan and Anne Raskin v. City and County of San Francisco, Janice Madsen,**  
8 **Kym Dougherty and Heather Grives.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. The City Attorney is hereby authorized to settle the action entitled "Maura  
12 Moylan and Anne Raskin v. City and County of San Francisco, Janice Madsen, Kym  
13 Dougherty and Heather Grives", United States District Court for the Northern District of  
14 California, Case No. C10-04700, by payment of \$762,000.00. The sum shall be allocated as  
15 follows: a) to Maura Moylan in the amount of \$171,000; b) to Anne Raskin in the amount of  
16 \$91,000; c) to Markus Willoughby in the amount of \$140,000 for attorneys' fees; and d) to  
17 Shea Law Offices in the amount of \$360,000 for attorneys' fees.

18 Section 3. The above-named action was filed in United States District Court for the  
19 Northern District of California, Case No. C10-04700. The following parties were named in the  
20 lawsuit: City and County of San Francisco, Janice Madsen, Kym Dougherty and Heather  
21 Grives, defendants.
