Resolution urging San Francisco elected officials to support City College of San Francisco in maintaining its mission as a Community College and to support City College by finding new revenue sources.

WHEREAS, In an era of jobless recovery, mass layoffs and skyrocketing college tuition, City College of San Francisco is a beacon for all San Franciscans, from immigrants and displaced workers to cash-strapped families seeking educational opportunities for their children; and

WHEREAS, City College is the largest provider of workforce training in San Francisco, offering programs in growing fields such as engineering, nursing, and technology, providing job re-training to teach workers new skills; it is the largest provider of English-as-a-Second-Language (ESL) courses, and the college's partnerships with San Francisco's restaurant and hospitality sector and other industries are national models; and

WHEREAS, Five years of drastic cuts in state funding, literally tens of millions of dollars including \$17 million in state money in the last year, has resulted in shrinking programs and overflowing classes; skyrocketing costs to students and families; employee furloughs, pay cuts, and givebacks; shutting the doors on far too many students who are unable to get the classes they need; and an increasing sense that community college education and its mission are wholly threatened for our city's diverse students; now, therefore, be it

RESOLVED, That the San Francisco Board of Supervisors calls on all local and state officials to support City College of San Francisco in maintaining its mission as a Community College, serving the entire San Francisco community with its irreplaceable focus on low-income and underrepresented students for whom it is the only option, and, be it
