Be it ordained by the People of the City and County of San Francisco:

Section 1. This Ordinance is uncodified.

(a) In order to promote the 2012 Ocean Avenue Arts & Culture Festival and permit sidewalk sales of merchandise and other activities related to the Festival, the fee for temporary street space occupancy set forth in Public Works Code Section 724.1, subsection (b), shall be waived on September 15, 2012, between 7 am and 9 pm, in the following geographic areas of the City:

Ocean Avenue between Phelan Avenue and Faxon Street.

Faxon Street between Ocean Avenue and De Montfort.

(b) All other provisions of Public Works Code Sections 724 et seq. shall remain in full effect.

Section 2. Effective Date and Retroactive Application. This ordinance shall become effective 30 days from the date of passage; provided, however, that its terms shall be retroactive to September 14, 2012.
