14	Be it ordained by the People of the City and County of San Francisco:	
15	Section 1. The Planning Department has determined that the actions contemplated in	
16	this ordinance comply with the California Environmental Quality Act (California Public	
17	Resources Code Section 21000 et seq.). Said determination is on file with the Clerk of the	
18	Board of Supervisors in File No. 120142 and is incorporated herein by reference.	
19	Section 2. Article 7 of the San Francisco Transportation Code is hereby amended by	
20	adding Section 7.2.54, to read as follows:	
21	SEC. 7.2. INFRACTIONS.	
22	In addition to public offenses created by the Vehicle Code, the actions listed in this	
23	Section 7.2 are prohibited, and each and every violation of a prohibition listed below shall be	
24	an infraction, except as otherwise provided in: (a) this Code; or (b) the Vehicle Code; or (c) a	s
25	necessary to comply with the direction of a Police Officer or Parking Control Officer; or (d) wi	th

1	respect to a Municipal Parking Facility, upon the direction of an authorized parking attendant;
2	or (e) with respect to any other Public Property, except with the permission of, and subject to
3	such conditions and regulations as are imposed by the agency that owns the property that are
4	available for public inspection at the agency's offices.
5	SEC. 7.2.54. LARGE VEHICLE PARKING RESTRICTIONS.
6	To Park a vehicle over twenty-two feet in length or seven feet in height, or camp
7	trailers, fifth-wheel travel trailers, house cars, trailer coaches, mobilehomes, recreational
8	vehicles, or semi-trailers as defined by the California Vehicle Code and Health and Safety
9	Code, between the hours of 12 a.m. and 6 a.m. when Municipal Transportation Agency signs
10	are posted giving notice.
11	Section 3. Effective Date. This ordinance shall become effective 30 days from the
12	date of passage.
13	Section 4. This section is uncodified. In enacting this Ordinance, the Board intends to
14	amend only those words, phrases, paragraphs, subsections, sections, articles, numbers,
15	punctuation, charts, diagrams, or any other constituent part of the Transportation Code that
16	are explicitly shown in this legislation as additions, deletions, Board amendment additions,
17	and Board amendment deletions in accordance with the "Note" that appears under the official
18	title of the legislation.
