

1 [Contract Amendment - CCT Technologies, Inc., dba ComputerLand of Silicon Valley -
2 \$34,460,000]

3 **Resolution authorizing the Office of Contract Administration to enter into the**
4 **Third Amendment between the City and CCT Technologies, Inc., dba**
5 **ComputerLand of Silicon Valley (part of the Technology Store procurement**
6 **vehicle), in which the amendment shall increase the contract limit from**
7 **\$24,490,000 to \$34,460,000, exercise the second of two options to extend the**
8 **contract by one year through December 31, 2013, and update standard**
9 **contractual clauses.**

11 WHEREAS, The Office of Contract Administration, by competitive bidding,
12 developed the Technology Store procurement method for the purchase of products and
13 services related to Information Technology; and

14 WHEREAS, CCT Technologies, Inc., dba ComputerLand of Silicon Valley is one
15 of the three products vendors who are part of the Technology Store; and

16 WHEREAS, The original contract with CCT Technologies, Inc., dba
17 ComputerLand of Silicon Valley dated January 1, 2009 has a term of three years
18 through December 31, 2011 with options to extend the term through December 31,
19 2013, and has an original contract limit of \$24,000,000; and

20 WHEREAS, The Board of Supervisors approved the original contract on
21 December 9, 2008 by Resolution #508-08; and

22 WHEREAS, The Director of the Office of Contract Administration and the
23 Purchaser approved the First Amendment to the contract on December 14, 2011 to
24 exercise the first of two options to extend the contract by one year to December 31,
25 2012, and to update standard contractual clauses; and

1 WHEREAS, The Director of the Office of Contract Administration and the
2 Purchaser approved the Second Amendment to the contract on June 28, 2012 to
3 increase the contract limit from \$24000,000 to \$24,490,000; and

4 WHEREAS, The Office of Contract Administration estimates that the money
5 projected to be spent with CCT Technologies, Inc., dba ComputerLand of Silicon Valley
6 could reach the contract's limit in the reasonably near future; and

7 WHEREAS, Charter section 9.118, (b) "Contract and Lease Limitations,"
8 requires the Board of Supervisors to approve any contract estimated to exceed \$10
9 million in expenditures or amendments exceeding \$500,000 to such contracts; now,
10 therefore, be it

11 RESOLVED, That the Board of Supervisors authorizes the Director of the Office
12 of Contract Administration and the Purchaser to enter into the Third Amendment to the
13 contract with CCT Technologies, Inc., dba ComputerLand of Silicon Valley in
14 substantially the form attached to increase the contract limit from \$24,490,000 to
15 \$34,460,000, to exercise the second of two options to extend the contract by one year
16 through December 31, 2013, and to update standard contractual clauses.


